PLACEMENT IS ALSO DEPENDENT ON THE TOTAL NUMBER OF ALREADY SCHEDULED AGENDA ITEMS.</p> <p>SUBSEQUENT SUBMITTALS PART OF AN ACTIVE APPLICATION MUST BE SUBMITTED NO LESS THAN <b>14 DAYS</b> PRIOR TO THE MEETING DATE (EXCEPT PRELIMINARY OR FINAL PLAN REVIEW APPLICATIONS WHICH REQUIRE 21 DAYS, UNLESS WAIVED BY STAFF).</p> <p><u>THE SECOND MEETING OF EACH MONTH IS COMMITTED TO TOWN RELATED PROJECTS AND CODE AMENDMENTS AND NOT ACTIVE LAND USE APPLICATIONS UNLESS AUTHORIZED BY THE PLANNING BOARD (THIS DOES NOT INCLUDE NEW APPLICATION SUBMITTALS (COMPLETENESS REVIEW)).</u></p>
