RECREATION DEPARTMENT ANNUAL REPORT 2011-2012

To the Citizens of Kittery:

It is with great pleasure that I submit a Town Report for the Kittery Recreation Department. Having the privilege to work in a job for 29 years that I have such passion for and one that I enjoy going to every day is truly an honor.

We have made it through the major construction phase that started in July 2011 and some items are left to finish but overall we are up and running, working out the tweaks and the facility is gorgeous. J. Alden Tansey was the clerk of the works for the Town and he did a wonderful job and was such an asset to the project. If you have not seen it, please stop by anytime to take a tour. I want to thank the Frisbee Revitalization Committee; the Building Committee and the new KCC Board of Directors for their vision and dedication to this KCC project. Established are a new Arts and Culture Committee and a fundraising committee. The fundraising committee to date has raised \$95,000. This money has made it possible to have the last phase of the theatre approved and will be completed mid-October. The KCC will have a full service theatre to use and rent to the community for all types of events. We would not be where we are in this project without all of you. I cannot list everyone but will list the chairs; Chris Perkins/FRC and Building Committee; Jeff Thomson/KCC Board of Directors; Kent Stephens/Arts and Culture; and Faith Harrington/Fundraising, Kudos to all of you! It takes a village and KCC has many individuals stepping up to the plate.

In May 2012, the Kittery Community Center at Frisbee Common opened its doors to the applause of residents. This center is a place of beauty and residents of all ages are using it and taking part in the KCC offerings. Our brand new gymnasium

is used on a daily basis, day and evening, and individuals are truly enjoying being able to use this gym. The track and fitness suite is used daily and memberships are only needed for the workout suite. Our Preschool and all day care for 2-5yr olds opened on July 2nd and several adorable preschoolers are starting their education with Kittery Recreation. The department truly provides choices for 2 year olds up to 100 year olds. Our staff is here to assist you and please let the reception desk staff know how they may assist you on any visit. There is a suggestion box at the reception desk and we welcome your input.

In June the second annual Kittery Block Party was held in the Foreside Area. Many individuals work behind the scenes to make this day the most enjoyable for families and friends. Bob's Clam Hut and York Hospital were the presenting sponsors. It was a very successful event and enjoyed by thousands.

In September, we will be offering new classes in salsa, acting, ballroom dancing; zumbatomics, chair yoga, pilates; writing workshops, editing, art, private fitness training opportunities, yoga, pilates, adult basketball leagues, volleyball, rental opportunities for community kitchen usage, theatre rentals, wedding and other receptions, birthday parties, conference space and much more. Stay tuned, we have only just begun.

Our S.A.F.E. after school program for youth in K-8th grade had a great year with lots of new daily activities for our participants. This program is licensed with the State of Maine and is housed at the Kittery Community Center on Monday-Friday 2:30-6pm.

Our "Concerts in the Park Summer Series", was held at the Kittery Common and was enjoyed by many. KENNEBUNK SAVINGS has been our sponsor for this series since 2003. THANK YOU!

Since 2001 YORK HOSPITAL has provided \$18,500 to assist our low-income families each year. This is amazing and so generous. The recreation director administers this program after an extensive application process. This program is very valuable to our residents, providing assistance with daycare during the school year and summers. Some adults have used this for a class or trip that they may not have been able to attend. Many families take advantage of this generous gift and have been provided with reduced program fees as a result. We wish to thank York Hospital, our neighbor and friend, for this generous contribution to Kittery!

Please remember their community spirit and generosity. With much gratitude THANK YOU Mr. Knox and the YH Board of Directors! How exciting for Kittery with the new YH Kittery location opening in September!

Additionally, thanks goes out to the Town Manager, Robert Markel, the Town Council and Municipal staff for the support you have shown this Department throughout the year. Police and Highway worked extra hard for the Block Party and that was very much appreciated by all.

Last but certainly not least, thanks to my staff who work each and every day assisting me in "Creating Community Through Recreation!" "Job well done by a fabulous team!" I appreciate your dedication to Kittery Recreation and the citizenry of Kittery!

POLICE DEPARTMENT ANNUAL REPORT 2011-2012

To the Citizens of the Town of Kittery:

On behalf of the Kittery Police Department I want to thank the entire Kittery community for their ongoing support of their police department. It is this community support that allows us to be a professional and proactive law enforcement agency. My commitment to the citizens of Kittery is to continue to strive to make our town the safest place to live, conduct business and enjoy the ever-growing number of quality-of-life opportunities this beautiful area has to offer.

During a tight budget year, I want to thank the Town Manager and Town Council for continuing to support the Police Department in our efforts to protect the citizens of Kittery. We received support to purchase two new police cruisers and replace our outdated cruiser radios. We received an increase in funding for our training with the goals of improving delivery of service, enhancing career development of our officers, providing better management through accountability and using technology to operate more efficiently.

Faced with the objective of maintaining services with fewer resources, it was apparent that we needed a transformation in our command structure and policing strategies. We had to labor through the multitude of challenges required to transform the organization into a much leaner department while at the same time preserving our core values of reducing crime and improving the quality of life opportunities for our residents and visitors. As a result, we have reduced the number of supervisors from 7 to 4, we have created a bicycle officer and assigned a School Resource Officer to our schools.

The Police Department has worked closely with the school department to create the new School Resource Officer position. This position will begin at the start of the new school year, and we look forward to the positive impact the position will have on Kittery's school age residents. The SRO will provide a safe environment in the schools, reducing crime, drug abuse, and violence through intervention and prevention. In addition to this, the SRO will focus on teaching and mentoring,

providing guidance and positive interaction between children and the police department. This interaction will assist in fostering rapport between the students and police, resulting in long term crime prevention.

The other new position created this year is the bicycle officer. This officer patrols high pedestrian traffic areas, such as the malls, beaches, and parks, on a mountain bike. This enables the officer to have close interaction with pedestrians, as well as providing highly visible patrols in areas where police vehicles are not practical and provide a rapid respond to emergency calls through congested traffic. The bike officer focuses on the malls and beaches, and his presence provides an excellent deterrent to crime in these potential problem areas.

The blueprint for the transformation of our policing strategies has been analyzing our crime locations and traffic crash data to determine the most effective methods for deploying law enforcement and other resources. Crimes in our town often involve motor vehicles. With this understanding, we believe that high visibility motor vehicle activity will reduce crimes, car crashes, and traffic violations. Through our analysis, we have identified target areas and specific time frames where we concentrate our efforts. To date, we have doubled our motor vehicle traffic stops and reduced car crashes in these targeted areas.

In closing, I would like to offer my genuine and heartfelt thanks to all the men and women of the Kittery Police Department, who have stepped up to the challenges of these difficult times and continued to deliver quality services to our community. I am truly proud to say this is one of the finest police departments in the state.

GRANTS

Friends of Rice Public Library funded a number of new programs and projects. The Friends sponsored our ever popular museum pass program, the summer reading programs and family movie night. The Friends also funded a new digital projector and screen for the library. The screen and projector were used for Family Movie night. We are very grateful to have received a \$2,500 from the Rosamund Thaxter Trust for the additional purchase of AV materials for the Children's collection at Taylor building. Lions Club of Kittery generously supported the purchase of Large Print books with a donation of \$1,000.

DISPLAYS

This year to commemorate the closure World War Memorial Bridge the library had a display of old photos from the Rice Library Maine room collection as well as more recent photos by local Photographers: Dudley Bierau, Joseph St Pierre and Rawson Sillsby. The entire project of scanning the original bridge construction photographs and creating the poster and canvas prints was the work of Colleen Evans. Colleen spent many hours scanning the photos and selecting the best ones for the display. Thank you Colleen! The library has been selling posters with re-prints of the Memorial Bridge under construction.

MAINTENANCE

In order to reduce our overhead costs at the end of last summer we replaced the burner at the Rice Building and this summer the furnace at Taylor will be replaced. The boiler was 40 years old so we anticipate some saving in the fuel costs this year.

Other major repairs include removing the old wooden gutters at Taylor, installing new gutters and adding de-icing cables to prevent large icicles from forming over the back entrance of the Taylor building. A new larger book return that can accommodate the return of DVDs and Books on CD safely was added at the Rice Building. In June sections of the Taylor parking lot and front sidewalk were re-paved.

YOUTH SERVICES

Rice Public Library's Youth Services has had a phenomenally productive year. We offered a total of 117 programs, with a total attendance of 6,262 attendees, our highest numbers achieved yet. We have had 321 registrants for our Summer Reading Program, Dream Big: Read. Our programs offered this year were widely varied. In-house programming included Toddler and Preschooler story times, a Babygarten group, Family Movie and Reading Nights, special events themed around holidays, Titanic, Paper Airplane, and Wii Gaming nights, a Parent-Child workshop series, African Dancing and Drumming, Cub Scouts Folktale

Merit Badge Night, a Police & Fire Story Time, a Movie Night at Fort Foster, and numerous special performers such as Peter Boie, the Tardy Brothers, the X-7 Wildlife Show, mimes and jugglers. For community-outreach purposes we visited local schools and preschools for story times, and to disseminate information about the library (including library card sign-ups, programming and teacher resource information), as well as to support the 100 Book PTA effort. We also offered intergenerational programming with Kittery Estates throughout the year.

Regarding grants received, we received several these past years to supplement our annual budget. Youth Services received a \$2500 grant from the Rosamond Thaxter Foundation for parenting materials and children's audio books. We also received generous support from the Friends of the Library for two programs, a new DVD projector, and the yearly support of our monthly movie nights. Their total grant funds came to \$2121.30. We also have had several wonderful donors give money ear-marked for a new shelving/seating unit in the children's room that will house our multimedia collection and provide a cozy reading space. Those funds donated came to approximately \$2,000. Thus, total funds granted to Youth Services came to approximately \$6621.20 that assisted us in stretching our budget to best assist our patrons with their needs.

VOLUNTEERS

Our dedicated volunteers greatly assisted us with processing interlibrary loans, programming, shelving, and special projects. A special thanks to volunteer Jean Arris for maintaining our Maine Room collection and answering genealogy and local history questions. FIRE DEPARTMENT ANNUAL REPORT 2011-2012

To the citizens of the Town of Kittery:

The Fire Department is in excellent working order and continues to provide a service to this community for a very modest amount of tax dollars. We are able to do this because of the many dedicated "call" firefighters who continue to spend many hours training and preparing to help their neighbors when in need. Our "call" force comprises over 50 firefighters who are trained to the same levels of a "professional firefighter". Firefighting is not their job, it is their hobby and passion and Kittery is fortunate to have them on our staff. Two of our firefighters, Tyler Doucette and Jeremy Edwards, completed Level 1 and 2 firefighter certification (244 hours) and are now active members of our well trained firefighting team.

The Fire Department received a grant for \$7,000 from the Stephen and Tabitha King Foundation for the replacement of two automatic external defibrillators (AED's). The new units which are in service are adult and child capable. We also completed the first year of a two year plan to replace our protective clothing. The National Fire Protection Association dictates a life span of ten years for protective clothing. Through the Capital Improvement Program (CIP), we were able to replace twenty fire sets of clothing that were ten years old at the end of 2012. An additional twenty fire sets will be purchased through next years CIP. The CIP also supported

antenna and communication upgrades for both fire and police. A new antenna is now operational on top of the Kittery Water District tower on Rogers Road. This is the highest point in Kittery and supports line of sight communications throughout the Kittery and Seacoast areas. Our emergency radio communication capability has improved dramatically from this upgrade.

CONSERVATION COMMISSION ANNUAL REPORT 2011-2012

We welcome Kittery residents interested in serving on the Conservation Commission. Regular meetings are held on the first and third Thursday of each month at 5:30 pm in the conference room of the town hall.

Coastal Cleanup was held on Saturday, October 1, 2012 at Seapoint and Crescent Beaches, Rogers Park, and Eagle Point. 23 volunteers cleaned 3+ miles, collecting over two hundred pounds of debris. Shipyard volunteers also collected debris along the ½ mile of the Portsmouth Naval Shipyard.

Town Farm Forest - The foundation of the old Poor Farm house will soon have a sign that provides interesting historical information on this old Kittery landmark. Many thanks go to the Public Works Department for their hard work cutting a new section of the Haley Trail to take the trail further away from the Clover Landing development.

Lobster Trap Cleanup was held on Saturday, April 14, 2012 from 8:30 am to 11:00 am. Harbor Master, Michael Blake joined volunteers to remove about 65 traps from Seapoint and Crescent Beaches. These were transferred on a dump truck provided by Public Works. Another beach cleanup was held two weeks before and many lobster traps were collected at that time. Again many thanks to Public Works, and all the volunteers who worked so hard to help us keep our beaches cleared.

Adopt-A-Road program, established and administered by the Kittery Conservation Commission and endorsed by the Kittery Town Council on July 15, 1996, is designed to allow private citizens and groups an opportunity to support the Town of Kittery's anti-litter efforts by adopting a town road/street or section thereof located within the Town boundaries. At that time the State of Maine did not have such a program. The first cleanup was in November of that year.

Currently, forty-four (44) individuals, families and groups clean seventy-one (71) roads or road sections. This includes our newest adopter, Fran Holly, who has adopted Norton Road between Haley and Miller, as well as unofficially helping other adopters clean roads in that area on a loop she walks regularly. Certainly, all citizens are welcome and thanked for picking up roadside litter as they see it. Welcome to the program, Fran!

We have noticed that some of our signs need replacing, so Steve Hall and Alan Kelly will be doing that this year, as well as they install our new signs. Thanks so much!

We continue to seek new volunteers to adopt available roads such as Dennett, Manson, Norton and Lewis, and avenues such as Tilton, Newson and Manson. The intial commitment is two years and to clean at a time of one's choice in April, August and November. Please join us to "Keep Kittery Clean and Beautiful!" To join, contact the co-chairs, Susan Emery or Janet Gourley

Open Space Committee KCC continues to serve on this important committee to identify and review town owned property and right-of-ways.

Planning Board continues to work on ordinance updates and the Comprehensive Plan for Kittery. The Conservation Commission serves as an advisory to the Planning Board and the Board of Appeals.

PREP Grant KCC has received a PREP Grant to identify and evaluate wetlands and vernal pools in Kittery. As soon as funding is available, the information gathered will be added to the town's GIS maps.

TOWN PLANNER ANNUAL REPORT 2011–2012

Improving the quality of Kittery is the goal of the Town Planning and Development Department. The aim is to make the Town better; better for you, better for your neighborhood, better for the environment, better for business, better for financial value.

Since August 2009, we have intensified our work and much has been accomplished under the leadership of the Town Council, Town Manager, former Planning Board Chair Russell White, current Planning Board Chair, Tom Emerson and former and current Planning Board members. During this year Chairman Emerson was elected and unfortunately member Earl Donnell decided to resign due to a death in his family. Moving forward ongoing Vice Chair Dave Kelly, Bob Melanson, Susan Tuveson and Debbie Driscoll were joined by new appointees: Rich Balano and Ann Grinnell.

Additionally, this includes working with the new Economic Development Committee and the ongoing Comprehensive Plan Update Committee and other Boards and Committees to improve Kittery. Again appreciation is extended to all of them for hundreds of hours of voluntary service to Kittery. Accomplishments include:

- Kittery Destination Marketing Program- Phase 1 implementation of the Town Council adopted program to expand business opportunities in Kittery including installation of approximately six new I-95 signs and other state in-town signs identifying Kittery destination locations and historic and cultural attractions. Signs to identify qualifying local businesses on I-95 are in progress. Thanks to the Maine Department of Transportation for their support.
- 2. Memorial Bridge reconstruction, possible improved lighting and mitigation including local business district signs and advertising.
- 3. Sarah Long Bridge reconstruction and related Route 1 By-Pass planning.
- 4. Kittery Community Center at Frisbee Common opened to create a real "town center" for indoor and outdoor civic activities. This included the planting of approximately twenty entry way trees made possible by a State grant.
- 5. Ongoing Growth Management Program and Comprehensive Plan Update review and initial re-affirmation of most current development policies, as well as plan and Town Code updates for further environmental/rural protection, economic development and overall development quality improvement.
- 6. Shoreland and Resource Protection by implementation of newly adopted Maine State mandates and related Town Code amendments.

- 7. York Hospital's pending opening of the New England architectural designed medical office building with street front and rear parking area landscaping at 35 Walker Street and State Road.
- 8. Coastal US Route 1 improvements south of the Town of York in cooperation with terrific work by Kittery Public Works staff.
- 9. Lewis Farm Road subdivision plan approval providing single family residences and open space off Lewis Farm Road.
- 10. Quality Improvement Plan (a specific plan) for Kittery Foreside and Foreside Crossing preparation continuing with the possibility of adopting an additional Municipal Improvement District enabling "tax increment financing" of public improvements.
- 11. Adoption of a Town Code to enable Kittery Foreside restaurants and businesses to have outdoor seating.
- 12. Quality Improvement Plan for Coastal 1 Kittery shopping area preparation continuing with the possibility of increased environmental protection and public awareness of local ecology, increased pedestrian connectivity, reduced vehicular trips, parks, outdoor cafés and seating, trolley service interconnected with other business districts and attractions and increased town revenues for citizen services.
- 13. Pedestrian and Bicycle Ways Plan preparation continuing with updated and new policies and implementation strategies to improve access and safety throughout the Town.
- 14. Quality Improvement Plan for Kittery Center Village preparation continuing with the Planning Board already approved establishment of a weekly, local Kittery Farmers', Fishermen (and women), Food and Artists' Market at Post Office Square.
- 15. Quality Improvement Plan for Memorial Circle preparation continuing with a supporting resolution adopted by Town Council to establish a USS Thresher submarine memorial, formation of a Project Group, and a planned Memorial flag installation and dedication ceremony on April 7, 2013 in Memorial Circle.
- 16. Town and regional planning and development project approvals benefiting Kittery via the Southern Maine Regional Planning Commission, Kittery Area Comprehensive Transportation System Metropolitan Planning Organization and Sustain Southern Maine partnering to strengthen our economy, environment and community by the collaboration with towns, cities and other public and private organizations in York, Oxford and Cumberland Counties.

Additionally:

 Kittery Community Center at Frisbee Common realization. This included finalization of mission, organization and governance; building and site plan; bond financing, and building construction in cooperation with the Town Manager and Recreation Director.

- 2. Growth Management Program Advisory Committee re-chartered as the Comprehensive Plan Update Committee to update the Town's Plan for the Year 2020.
- 3. Capital Improvement Program Five Year update adoption by Town Council.
- 4. Economic Development Plan and budget for FY 2013 preparation by the Economic Development Committee for Town Council consideration.
- 5. Conservation Commission, Kittery Port Authority, Kittery Open Space Advisory Committee and Parks Commission approvals of other planning and development/conservation improvements.
- 6. Property Maintenance ordinance adoption by Town Council and implementation with Code Enforcement and Public Safety Departments.

All this would not be possible without the leadership of the Town Council and Town Planning Board as well as voluntary services of committee members, and citizens and the terrific Town staff including new Assistant Planner, Chris Di Mitteo and our partners Heather Ross, Code Enforcement Officer; Shelly Bishop, Assistant Code Enforcement Officer; Amber Harrison, Shoreland and Environmental Resource Officer; Marcia Elton, Development Clerk, and Jan Fisk, Planning Board and Board of Appeals Secretary.

As we look to 2013, Kittery citizens will be called upon to make key decisions about what kind of Town do you want by the year 2020 and how to achieve it. So we look forward to helping in any way we can to improve the quality of Kittery.

PUBLIC WORKS ANNUAL REPORT 2011-2012

The past year has been a monumental year of NO snow for the Department of Public Works and the community. Kittery crew's plowed 10 sanding storms and only 5 snow storms to manage a mere 27" of snow! One snow storm was on Halloween and the next significant snow storm was in March.

A mild winter adds up to savings in the highway operating budget, in the salt and vehicle repair line items. We were able to complete some small projects that had been cut from our budgets previously. Both Emery and Memorial Field were surveyed to create current topographic plans, one more piece was purchased for the Fort Foster Playground, the football field was repaired and the first phase of an overall Parks Master Plan took shape. With many town wide facilities being updated in the past two years, the focus of our capital planning is towards the parks/athletic fields, paving and resource recovery efforts.

The Highway crew spent a good part of this year partnering with MDOT and others to improve Route 1, from Lewis Road to the York line. The project included new bicycle/pedestrian facilities, additional green space, improved development access, and repaved the roadway. Town crews did the majority of the work; MDOT contractors paved/striped the roadway. DPW built new sidewalks around the "When Pigs Fly" property; the Lewis Road link was only possible due to an easement granted by the owners. We also rebuilt the entrance to a potential development site across from Lewis Road, with cooperation from that owner, to be in better alignment with Lewis Road and allow space for future left turn lanes into the property off Route 1. The State Police worked with us on the plan to take out four lanes at the old weigh station and add 40 new maple trees! The partnership yielded very successful results and we look forward to working on more collaborative projects for the betterment of the Town as a whole.

The Pavement Management Program will be updated in the next year in preparation for a long term funding plan. There has been very little capital funding allotted to road paving in the past three years. Without a strong focus on preserving the roadways before they breakdown, capital funding needs would grow exponentially.

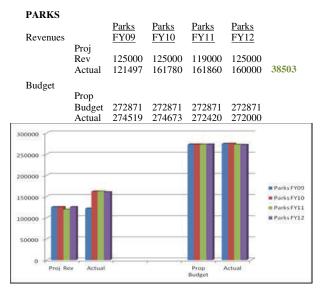
For Parks, Fort Foster Fees held a steady revenue stream of \$160,000 +/- for the last three years, despite the weather conditions. Therefore, I do not recommend raising fees, as I have already jumped the revenue projection for FY13 from \$125,000 to \$150,000. I recommend a rate increase for next year prior to the printing of the tickets and passes.

Fort Foster revenue from FY09-FY12 has increased by \$38,503. I do plan on increasing my bottom line budget by no more than \$38,000 to match the change in revenues (while the operating budget has been held to a zero increase for the last four years). There are unmet needs for manpower, maintenance supplies and preventative repairs. This is the first year we are working with the Police

Department to have an officer (on a bicycle) patrolling the park on a regular basis. Their presence and interaction with the public has been positive and educational.

The in-town parks crew gained many new areas to take care of while changes along the roadside become greener. We have kept their equipment current and continue to try to become more efficient and practical. A well and pump house was added to Haley Field for watering the new soccer fields; this option was a quarter of the cost compared to putting in a new seasonal waterline.

We have started an overall Parks Master Plan which includes reviewing, upgrading and mapping all open spaces, parks, athletic fields, land trust properties, and Rachel Carson parcels. Communication between all the partners and the public are the first steps. Our first, of many, Parks Master Plan workshops will be held this August. Our goal is to review the needs, plan for the future and prioritize the capital requests. The four draft pillars of the plan are: maintaining historical identity, preserving natural resources, creating quality/active lifestyles and building mindful connections.



For the Solid Waste Facility, we have continued to clean up and expand our services to the public. Earthlink Educational Series started with monthly educational classes held on site to learn about composting and gardening. Many local artists hand painted rain barrels for a fundraising effort to fund future Earthlink classes/ workshops. The Freebie Barn was expanded to include larger household items in a large, temporary tent placed beside our current building. After reviewing the immediate and long term success, we are deciding how to build a permanent structure to meet this need in the community. We are now tracking the weight of all items leaving the Freebie Barn to calculate the avoided cost of disposal. Kittery has partnered with EcoMaine to provide disposal services for the next three years. With the new rates, we saved almost 30% in lower tipping fees with the new contract!

Planning efforts were the main focus of management by creating a draft plan for "Kittery's Road to Zerowaste". The draft plan builds upon the eighteen month long task force, Solid Waste and Recycling Committee (SWRC)'s recommendations and addresses their concerns. I attended a conference in Austin, Texas to work with leaders in Zerowaste planning. Upon return, I worked closely with a team of residents, commercial partners, town and school staff to fine tune a draft plan headed to the Planning Board and Town Council for review later this summer.

DPW is planning a kick-off event for celebrating Kittery's Road to Zerowaste, in collaboration with the Seaside 4 Miler Road Race, on September 23rd, 2012 from 8:00am to noon to be held at the beautiful, waterfront location of Fort Foster. Entrance fees will be waived for everyone for the day! Throughout the morning, Soulmate, a local band, will play for us and announce children's activities, recycling awards winners, and outcomes from the rain barrel auction. Many vendors will be present to share their like-minded, environmentally friendly services and products.

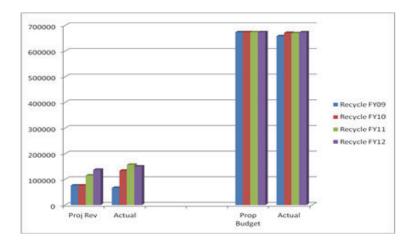
Our vision is to create a community based, zero waste initiative for all residents and businesses in and around Kittery, Maine...to start first in our town facilities and schools, to expand our current services to residents and invite area businesses and communities to partner with our initiative. All our schools are now composting in the cafeterias and have created green teams for each facility. All town facilities now have new colored totes and bins for expanded recycling and separation of materials.

Zero Waste is a shift from waste management to materials management. This new approach treats materials collected as resources that have secondary lives, not as waste streams destined for landfills or incinerators. Thus, Zero Waste is redirecting the Department's mission toward resource recovery. This new paradigm shift, the Department name of Solid Waste Facility no longer represents our mission. As we embrace Zero Waste, our facility will be renamed to better reflect the new vision and mission.

User Fees/Permits revenues held a steady revenue stream since the rate changes in 2010; therefore, we are holding at a projected FY13 revenue amount of \$100,000. The Recycling revenue from FY09-FY12 has increased by \$94,819. I do plan on increasing my bottom line budget by no more than \$94,000 to match the change in revenues (while the operating budget has been held to a zero increase for the last four years). This area is our greatest potential for additional revenues and regional activity. There have been two dips (50% +/-) in the market for recycling revenues, in FY05 and FY08. We do not anticipate a big dip in the market for this coming year.

The Traffic Signal Improvements Project for the intersection of Route 1 & Route 103 (Walker Street is now under construction! The project now includes new storm drain infrastructure relocating the current lines along the railroad tracks into our road right-of-way. We can thank MDOT for including this important upgrade to a signal project. The cost of the project grew from \$420,000 to 1.3M due to the expanded drainage work; the match for Kittery is \$250,000.

The Memorial Traffic Circle redesign is also underway along with new sidewalk plans from the circle to the mall road and up to the new Kittery Community Center. Three concept designs will be ready by this December for the public to comment on and fine tune. Although the circle construction will not be done by the Thresher Memorial Celebration, we hope to have at least the 130 foot tall flag pole installed and operational.

Kittery is planning and creating the next 5-year program for a new General Permit for the Discharge of Stormwater from Small Municipal Separate Storm Sewer Systems (MS4). The trial position for a Shoreland Educational Officer was developed into a permanent part-time position in Public Works. Their responsibilities include management of the MS4 permit requirements, shoreland code enforcement/education and all environmental/recycling education/outreach efforts. The GIS mapping site was updated with data files; the new aerial photos will be added this fall.

Heading into my third year in Kittery DPW, I look forward to continuing collaborative efforts with my peers to continue providing quality services to the residents of Kittery for safe roadways, improved bicycle/pedestrian facilities, well-maintained parks and green space, and operating an efficient Solid Waste Facility.

KITTERY SEWER DEPARTMENT ANNUAL REPORT 2011-2012

To the Citizens of Kittery,

This year is the first season of using a renewable energy source (wood pellets) for heating the wastewater facility and its out buildings. This will help offset the cost of high oil prices and lower our carbon footprint. Our goal to continue to reduce the energy cost at the facility and the 21 pump stations in town.

Last September we noticed that we were losing DO (dissolved oxygen) in the processing tanks, with further investigation we discovered that the airlines that deliver the air were deteriorating and in need of relining. The relining was completed at the cost of \$150,000.

The work was performed by A&W Maintenance out of Carver Massachusetts.

The new liner is expected to last 50 years plus.

The Town of Eliot's 200,000 gals additional capacity request and 236 sewer extension was put to vote June 12th and was narrowly defeated 650 to 635 it will be voted on again in November. Negotiation with the existing contract with Eliot is ongoing.

SEA Consultants out of Cambridge MA is currently working on a five year CIP for Kittery Wastewater, 3 to 5 million is the estimated amount for facility, pump station and infrastructure improvements.

The Infiltration and Inflow work is still ongoing. During routine maintenance, discovering older sewer lines with infiltration are repaired and sealed when found. The Kittery sewer department and the Portsmouth Naval Ship Yard and the town of Eliot have been working together to address there infiltration problem as well. The Shipyard is scheduling major upgrades in there infrastructure both at the Yard and the Navy housing. An issue we will be working on (which has been ongoing) is to remove as many sump pumps as possible which homeowners have connected into the sewer. Sometimes homeowners don't realize just how much water this

can add, but every time it pumps (and anyone who has one knows the sound when turns on) a sump pump can add 20-50 gpm to the sewer. This is water that we have to treat which is costing everyone connected. We would gladly talk to anyone who is connected and give suggestions on how you can separate this from the town's municipal sewer. Kittery and Eliot continue to work together on a new Inter municipal Agreement. Hopefully one will be reached this year.

I would like to thank the citizens of Kittery, the town office staff and administration, and the employees for all their support and hard work, especially during the storms when working long hours, hauling generators to 21 pump stations during power outages, which keeps us from any interruption in service.

The Kittery School Department continues to move forward in their efforts to meet the needs of students each and every day. Staff members are committed to expanding the learning opportunities, raising expectations and supporting the students who need extra time and differentiated instruction. It is crucial that we prepare the students in our classrooms with the 21st century skills needed to be successful.

- Completion of the Mitchell and Shapleigh additions within budget
- Successful negotiations without the use of funds for legal facilitation
- Expanded grant searches to support district work

While the many successes reflect the hard work and dedication of staff, there are still challenges that face the School Department. As we begin our planning for the 2012-13 school year, the Leadership Team has committed to a focus on K-12 curriculum/assessment alignment, raising the rigor/academic expectations for all and exploring learning opportunities within the Kittery community.

In closing, I would like to express my sincere appreciation for the tremendous support the community provides to the students of Kittery. As evidenced through business internships, community service opportunities, mentors/volunteers, fundraising, PTA involvement, attendance at school events and scholarship support for the students, it is clearly evident that Kittery cares. My door remains open and I am committed to listening to and working with the citizens of Kittery to ensure growth and improvement.....we must continue to move forward!

Notable accomplishments this year included:

- Being selected to receive a "HealthierUS Challenge Bronze School" Award. This award recognizes excellence in nutrition and physical activity by the United States Department of Agriculture.
- Implementing a grade three, student initiated, "Green Team." After designing a system for collecting white paper and mixed paper, cans, bottles and plastics throughout the school, the students developed a presentation for their peers and the staff to educate them about the benefits of recycling. The Green Team then tackled the challenge of recycling in Mitchell's lunch program. Now, the school composts all organic materials, and students are dedicated to ensuring that the lunch program uses only recyclable products. The students' work was recently recognized in the Maine Department of Education's Newsletter.
- Further developing our policies and practices surrounding our antibullying curriculum and program. Our staff worked with a national expert, Stan Davis, to assist and support the refining of our practices with this important issue.
- Instituting a digital approach to communicating with our school community through the launch of a Mitchell School "facebook page."

We look forward to providing a quality educational experience for all learners in the coming school year.

SHAPLEIGH SCHOOL TOWN REPORT 2011-2012

Shapleigh teachers of reading continued their third year of the teaching and implementing of reading workshop. Grade level meetings were devoted to discussion around the teaching and assessing of reading, and schedules were created to accommodate the time necessary to implement reading workshop effectively. Under the direction of Literacy Coach Miranda Casey teachers created common assessments aligned with clear learning targets.

The submission of our Continuous Improvement Priority School (CIPS) plan was a major focus of our work for the 2011-2012 school year. Although we continue to work on all aspects of the plan, we have made significant progress with the following objectives:

1. All teachers of reading have a common understanding of reading instruction and are working to implement it effectively in their classrooms.

- 2. Reading is being taught using a reading workshop model based on the work of Lucy Calkins at grades four and five and Suzette Youngs and Frank Serafini in grades six through eight.
- 3. At weekly grade level meetings, teachers of reading reflected on their instruction and student learning.
- 4. Teachers of reading are using common assessments to evaluate the progress of students on specifically targeted skills.
- 5. All teachers of reading are utilizing differentiation and data to meet the needs of individual students.
- 6. Teachers of reading are fine-tuning a consistent implementation of reading strategies across grade levels and content areas.
- 7. A subcommittee of CIPS has begun the process of informing instruction from data.
- 8. A subcommittee of CIPS has begun the process of monitoring and evaluating the effectiveness of our initiatives.

In the fall students took the New England Common Assessment Program (NECAP) assessments in reading and mathematics in grades four through eight and in writing in grades five and eight. Our improved scores on the NECAPs are attributed to the combined efforts of both staff and students. Before taking the tests, students were given two targets:

1.Students were asked to improve their own grade level percentage of students who met or exceeded the standards by at least 5% in each area. Grade five students were asked to improve the writing score by 15%.

2.Students were also asked to strive for the State AYP targets of 83% in reading and 80% in mathematics.

The seriousness and enthusiasm that students exhibited during the testing process was both noted and appreciated and is definitely reflected in student scores. The effort of all of the Shapleigh staff in working with each other and with students has yielded an improvement in student achievement. We will continue this work as outlined in our plan that has recently been submitted to the State as part of our CIPS 1 status (Continuous Improvement Priority School). We are fortunate to have working with us Frances Farr, our consultant from the Maine Department of Education and a resident of Kittery Point.

The results of the NECAP provide useful information to teachers, parents, and administrators regarding individual student achievement compared to state standards and expectations. The assessment data also provides important information for curriculum, programming, and instruction. In addition, the results are used in determining whether our schools and district make Adequate Yearly Progress (AYP) as defined by the No Child Left Behind federal legislation. We are proud to say that Shapleigh School made AYP for this past year. Our results are depicted in the chart below:

Shapleigh School has continued its work with Expeditionary Learning (EL). Eighth grade students under the direction of Doug Bertrand, Karissa Lemont, Gabe McCahan, Chris Pirkl, Kate Sheldon, Terri Anderson, and Rachel Dostie ran their What is truth? unit for the second year. Students selected a topic of interest that was underrepresented in the media. Using an interdisciplinary approach, they researched their topic in social studies, studied propaganda and persuasive writing in language arts, and manipulated their data in mathematics. Students presented their work at the Kittery Art Association where they demonstrated their knowledge of the topic and of the persuasive techniques they had learned.

A current focus in education is to garner interest and prepare students for entering the STEM fields: science, technology, engineering, and mathematics. This year the eighth grade added SeaPerch, a second Expeditionary Leaning unit, made possible by grants through the Shipyard and the Kittery K-8 PTA. Working with parents and volunteers from the Portsmouth Naval Shipyard, students created a remote control robot, designed to carry out specific tasks underwater. Building on the robotics theme was the creation of a Lego's Club under the direction of Steve Frost. Students participated in contests where they created robots made out of Legos, designed to do specific tasks.

Under the direction of Robyn Angus, Mark Gunter, Stephanie Holland, Nancy Sebert, Steve Williams, Jennifer Foye, and Rich Wicker, grade seven students continued their work on the Bridge Project, a two-part endeavor. In December, students designed and built bridges made from toothpicks and held contests to see which bridge could support the most weight. In the spring, they designed a bridge that would be a model for the Memorial Bridge connecting Kittery and Portsmouth. Experts from the field met with students, and some students met with businesses on both sides of the river to ascertain how the closing of the bridge has affected them.

Grade six teachers. Agnes Bowen, Peter Cady, Nancy Long-Broughton and fourth grade teacher Corrine Gagnon, spent two days at King Middle School to learn first hand about Expeditionary Learning (EL). They are currently planning an expedition for next year. School counselor, MaryBeth Carbine, literacy coach, Miranda Casey, mathematics coach, Doreen Carson, and technologist, Seth Cole joined me at a conference at UNH to gain an understanding of EL and how we can best support teachers and students in that endeavor.

Shapleigh students participated in numerous contests this past year. For the second year in a row, grade eight students under the direction of social studies teacher Kate Sheldon participated in the We the People Expo at USM in Portland. We the People is a national program sponsored by the Center for Education. Students are assigned a unit of study on a topic related to the US Constitution such as federalism, freedom of speech, freedom of religion, and citizen participation. Students prepared several four-minute opening statements, as they did not know which set of questions the judges would select. They also had to prepare for a six minute "Q and A" session, where the concepts they discussed were probed in depth by the judges. Shapleigh's students were articulate and confident in facing the judges' questions, and the feedback from the judges was overwhelmingly positive.

Maine law Title 20-A §4706 requires that students be taught Maine Native American History, and the state sponsors an essay contest for students to share what they have learned. Both the first and second place winners in the 2011-12 Maine Native American History and Culture Essay Contest were from Shapleigh School. Maeve Dow earned first place honors for her essay on how the Passamaquoddy Tribe at Pleasant Point is addressing social issues, and Taylor Kashmer earned second place for her submission reviewing the history of Native Americans serving in the United States Military. Both girls and their classes were invited to be Secretary Summers' guests for a day in Augusta, where they toured the State House, the State Museum, and the State Archives and viewed original treaties with Native peoples and original field books of the early European explorers.

Shapleigh School participated in the National Geographic Geography Bee. Two students from each grade level were chosen based on grade level assignments and bees. Seventh grader Jeffrey Wansley was the winner and fifth grader Bella Woollacott was the runner-up.

With assistance from OM coordinator Andy Weatherhead, Shapleigh performed very well this year in the OM competitions and sent two first-place and one second-place team to the World Finals in Iowa. A second place team from Mitchell also joined them. First place team comprised of eighth graders Blue Clark, Alex Foye, Ian Lieber, Taidgh Robinson, Nathaniel Thomas, and Gunnar VonHaden, created a skit based on the Cold War with scientists developing a freeze ray to take over the world. The other first place team comprised of fourth graders Emma Ackerman, Sydney Auclair, Mack D'Angelo, and Molly Stites, and fifth graders Timothy Olcott, Noble Clark, and Kaleb Roth created a Christmas skit in which elf scientists had to detect why the ice was melting.

The annual art show at the Kittery Art Association featured the work of many of our young artists. Shapleigh again hosted visitors from Japan during April, and this summer several students will be visiting Japan accompanied by fifth grade teacher Joanne Voltaire.

Shapleigh had some excellent service projects during the year. Fifth grade students Betti Stevens and Katie Johnson spearheaded the Making a Difference group. Throughout the year they sponsored fundraising activities such as a hat day and the sale of bracelets they had made. They raised over five hundred dollars and at a

special luncheon donated three checks for \$170 each to three local organizations. Grade six students raised over \$500 for the Coins for Cures for Boston Children's Hospital, and they also have raised money by recycling through the Clynk program at Hannaford's. Grade seven students adopted the care of the courtyard by weeding and planting.

The Shapleigh learning community continues to nurture a safe and caring environment for all members of our community. We continue to work with Stan Davis on creating a Culture of Kindness. Teachers put forth a great deal of effort in communicating with parents in person, by telephone, email, websites, Infinite Campus, and newsletters. Shapleigh staff work industriously to bring our mission statement to life by help[ing] students grow in mind, body, and spirit, in a safe and caring environment.

Shapleigh lost several dear and longtime friends to retirement this year. Retiring were Fran Dupont, speech pathologist, Bee Cloutier, mathematics coach, Eleanor Krueger, fourth grade teacher, Terri Anderson, paraprofessional, and Patty LaClair, kitchen manager. We wish them the very best in their retirement. Robyn Angus, seventh grade mathematics teacher has taken a job teaching in another state, and Mark Gunter, seventh grade science teacher and co-advisor for Little Amps will be pursuing other ventures. We will miss all of them but will long remember their dedication and commitment to the students of Kittery.
