- I. Call to Order at 6:04. The required quorum of voting members was not present. The meeting continued as a Working Session.
- **II. Public Comment -** Steve Luber introduced himself and expressed interest in becoming a member of the board. Members introduced themselves and welcomed Steve. Currently the Board has two open positions.

- **B.** Reports & Committee Updates
 - 1. KCC Director's Report/Updates December (see attached). In addition, Jeremy noted:
 - KCC will work with York Recreation to schedule games.
 - Ice Dance International is scheduled for January 24-31.
 - The program guide will be lighter in January due to the impact of COVID.
 - For the Harvest Luncheon, pick-up may be an option.
 - Renewals are going well.
 - The elevator is still down. We are waiting on a breaker replacement.
 - 2. VAC Meeting Notes/Updates November (see attached). In addition, Gerri provided updates from December:
 - Current Morgan Gallery show has yielded \$1973 to-date. Price point is significant.
 - The Traip Show, Deck the Halls, will be displayed in April.
 - January-end of March 2022: "Boldly Looking Ahead" by Anita Loomis.
 - May-August 2022: "29 Mainers" by Erin Moore.
 - September-December 2022: Jim Ryan
 - Steve will talk with Faith regarding VAC developing a process for collaborating with artists and memorializing the displays.

 - Work is being done on field policies to best accommodate the considerable number of offerings.
 - Consideration is being given to have funds for Phase 3 put into the development of Memorial Field as a multiuse field.
