# PORT AUTHORITY MEETING Council Chambers

#### 1. Call to Order

Chairperson Philbrook called the meeting to order at 6:00 PM.

Members present: Bruce Crawford, Vice Chair, Steve Lawrence, Member; Kelly Philbrook, Chair, Charlie Patten, Member, Bryan Bush, Member, Niles Pinkham, Member.

Absent: Mark Drummond, member, and John Brosnihan, Harbormaster.

Chair Philbrook cast 1 vote to adopt the agenda as presented.

4. Acceptance of Previous Minutes - July 10, 2019

Mr. Lawrence moved to accept the July 10, 2019 minutes as presented. Vice Chair Crawford seconded the motion.

Motion carries 6-0-0.

## 5. Harbormaster Report and Budget Report

Chair Philbrook asked the board to see Harbormaster Brosnihan if they have questions related to the budget report which was included in their packets since the Harbormaster is not in attendance.

Chair Philbrook read a written report from Harbormaster Brosnihan who stated that he was absent due to the tall ships arriving in Portsmouth. Harbormaster Brosnihan's letter noted that squid fishing has increased, which he and the Assistant Harbormaster have been monitoring. Harbormaster Brosnihan also stated in his letter that on July 25, 2019 a sheen and odor of diesel fuel was observed in Pepperrell Cove, which was investigated and determined to be from a vehicle transitioning in the harbor channel. Harbormaster Brosnihan noted that he has contacted all mooring holders who have mooring inspections due, and he has inventoried the vacant moorings in Pepperrell Cove, with a result of 104 vacant moorings. Harbormaster Brosnihan's letter stated that the annual National Night Out event is taking place on Tuesday, August 6, 2019, and he will be participating.

Chair Philbrook acknowledged that Harbormaster Brosnihan has received several complaints of noise/partying on Brave Boat Harbor.

The board discussed the application, including a request from an abutter for more information, and the height difference between the dock and float.

Mr. Lawrence moves to accept an application from the Town of Kittery, 6 Bellamy Lane (Map 27, Lot 49A) for the addition of an 8' x 29.75' float.

Mr. Bush seconded the motion.

b. The Kittery Port Authority moves to hold a public hearing to approve Rules and Regulation changes to the following sections.

Chair Philbrook stated that all requested changes have been made for 3.12 - Moored Floats.

Mr. Lawrence moves to accept regulation 3.12 - Moored Floats as drafted on 8/20/19. Mr. Pinkham seconded the motion.
