- II. PUBLIC TIME: A group of Bartlett Farm development neighbors shared their concerns about 2 vacant lots and possible wetland problems. One read a letter outlining the history, current state, and questions about 2 very different site maps. We recommended that they contact the Planning Board and Maine DEP.

- V. OLD BUSINESS
 1. Town Farm Forest - 'unwanted contact with dogs'; public health and safety, bench, wetland crossing. This is one of the items that Earldean discussed with Kendra at her recent meeting. Steve will check the wetland and trail.
 2. Rogers Park – dogs-leashes/waste- T.C. Workshop on December 9, 2019. Steve will check out the trails.
 3. Kendra's Advisory Committee (KLIC) -10/21 Ordinance update. The Town hired an individual to work on the Ordinance update. Work is underway. Investigation is needed into the balance of the Wetlands Fund.
