 and in November had reinstated the energy advisory committee. This

 not limited to: sustainability, renewable energy, education on energy

- efficiency, wind turbine status and a review of the energy efficiency assessment completed previously. Janice and Kendra will connect the chair with the lead on this committee. Jean and Kristi will take the lead with communication, on the board's behalf, and update at the next BOD's meeting.
- Youth Athletics sub-committee- Dot expressed her interest in taking the lead on this. Dot suggested that this committee's role will be to assist/support the KCC staff with all youth athletic programs. Some tasks may include running concession to generate more income for these programs. Organize volunteer training for referees and coaches. Organize skills clinic and camps for youth. Collaborate with other existing Kittery youth athletic groups (Kittery little league, lacrosse, travel soccer, travel basketball) to share resources to achieve common goals.
- The board will move forward with creating this committee applying the same committee format as the VAC. Mike and Eric may also be interested in participating on this committee. The BOD will assign board members to this committee then will open up to the public. Kristi will work on a draft set of bylaws for the next BOD's meeting.
- Senior programming- Renaming "Senior Programming" was discussed. Some suggestions were to change senior to retired, change programming to Services, Vital living, and Kittery Senior Services (KSS). Kristi proposed we create a grant funded position to organize this program as this is a very large project and may exceed a volunteer position. Possible grants suggested include Kennebunk savings and York hospital. The question of who would write the grant was brought up with no clear answer. Kendra and Janice will discuss the options and follow up at the March meeting.
