- The new signs are in and most are installed. Mr. Alessi is planning to install more at Pepperrell Cove and Traip Pier this weekend.
- Mr. Alessi recently received the Government Street Pier assessment. He stated he has not had time to review the report and gave copies to the Board. Mr. Alessi added Barney Baker would like to attend the next meeting to go over his report with them. He added an immediate restriction of a 3.5-ton load limit was required on the pier and will be posted. The cost of the assessment will be taken out of their CIP. The Board was in consensus to have Mr. Baker at the July meeting.

Mr. Alessi described an incident involving a sailboat breaking loose. He explained a mooring holder's friend was renting his mooring which needed to be serviced. The pendent line was taken off but the boat owner wrapped rope around it and use it anyway. Mr. Alessi will be making the decision on what to do about the situation soon. Chair Philbrook hopes the owner is responsible for the fees to recover the sailboat and stated the Harbormaster has the ultimate control over the moorings and his decision to revoke. Board members discussed circumstances for making the decision to tow. Mr. Lawrence stated they currently have a no tow policy which has been used over the last two years. No tow unless damage to person or property.

Lisa Vickers, from ECO-Analysists, gave a review of the plan and explained the float will be on skids. The pier will be used on a seasonable basis for kayaks, paddle boats and a flat bottom skiff.

Mr. Cormier apologized not being at the recent site walk and hoped he clarified the questions from site walk.

Chair Philbrook explained the Board needs to consider the project that was originally applied for regarding the aluminum structure with the L-piece. The L piece is 8'x 8'. Chair Philbrook explained the question of access across the marsh grass was explained in an email. She further explained they need to go by the application as received and a public hearing and abutter's notice can't change. She also recommended going forward with original application and if Mr. Cormier would like them to continue to the next meeting to revise the plans. The applicant stated he would like to go forward with the current plan.

The applicant explained why the structure is not permanent and, because of that, it is wider than six feet on the end. He added the Army Corps of Engineers and Maine DEP stated they had no requirements for impacting the grass unless it is over used such as a warn path and they prefer an elevated walkway. Mr. Cormier added the impact would be low because the structure would be used for occasional kayaking. Chair Philbrook stated her concern with the temporary structure rolling off the marsh at high tide water between land and structure. The applicant explained the walkway would be temporary because it is soft foot using gangplanks.

The Chair opened the public hearing. There being none the Chair closed the public hearing.

- Vice Chair Crawford recommended seeing an addition to the plan showing the temporary ramp to the salt marsh. He is also concerned in keeping the temporary walkway from floating off. The applicant stated the walkway will be secured by auger ties anchored into the mud. The Vice Chair
- would like the applicant to come back next month with a revised plan showing all modifications.
