I am writing to comment that the way the ordinance is currently written is seemingly at odds with some other goals the town has around climate change, traffic control, and pedestrian accessibility.

By restricting the marijuana businesses to parts of the town that require cars to access (C-1, C-2, C-3 and M-U), we are reinforcing the town's reliance on vehicles for decades to come, and making it harder for us to develop a pedestrian accessible town. I get that the intent of this was to keep these businesses out of the core of Kittery, but by doing so, we are forcing Kittery residents to get in their cars and drive out to Route 1 or 236.

Allowing it in the business local or mixed-used (KF/BI) districts in addition to the commercial zones would allow Kittery residents to have a more accessible option, supporting efforts to decarbonize the town's transportation footprint and creating a more diverse and resilient group of businesses downtown.
