Town Manager's Report to the Town Council January 9, 2023

- 1. Council Representation on Boards, Commissions, and Committees** – As requested by Council, I polled Chairs and Vice Chairs of the Boards, Commissions, and Committees with Council representatives regarding their current make-up. I asked them whether they believed there is not enough, too many, or just the right number of Councilors appointed to their board, commission or committee.

The responses were thoughtful and clearly weighed the benefits and potential challenges. The Diversity, Equity, and Inclusion Committee is desiring the three Councilors who have been involved remain involved, though technically the Committee should only have two Councilors. All others desired to have no change to the number of Council representatives.

This poll was done at the Council request, as it desired input on whether to add Councilors or otherwise change Council membership on these various Boards, Commissions, and Committees. I am seeking Councilor direction on whether follow-up actions are wanted, such as amending ordinances to change Council membership on any of the boards, commissions, committees.

- 2. Freebie Barn** – The Freebie Barn opens Wednesday, January 11. Working with the Climate Adaptation Committee and Kittery Climate Action Now (KCAN), the new program to makes a variety of changes that will allow us to focus the types of items that are collected, assist residents with recycling and reutilization of common and urgently needed items, and reduce the number of items that linger at the Freebie Barn and ultimately end up in the waste stream. The Freebie Barn will be partnering with a variety of community organizations throughout the year to find new ways to recycle items that have not been repurposed by residents at the end of each month.

The new program also includes a monthly Community Swap event at the KCC that is open to all (not just Kittery residents) and will further decrease the number of items that end up in the waste stream.

The Town has developed a Resource Guide for residents interested in recycling items for those in need. The Resource Guide includes contact information, accepted items, drop-off information, and links to the partners. These partners serve our community and the region through assistance programs, social services, and other efforts. Recycling with these organizations may also be tax-deductible.

We are still seeking volunteers to help make this program a success! Support on Wednesdays and one Saturday a month is still needed. Please consider volunteering and being a part of our eco-efforts.

- 3. Grant Status** – December was a mixed month for grant results. The Town was notified late December that we did not receive the SAFER grant. This grant would have funded full-time firefighters for three years. In accordance with the Council approval in September, (see September 12, 2022 Mtg) we are

proceeding with hiring four full-time firefighters, bringing our total to 8, and resulting in full-time firefighter coverage 7 days a week. It is important to note, this does not provide 24-hour coverage nor does it provide a full firefighter force for major events. We still rely on our dedicated Call Firefighters to respond when needed.

We are awaiting confirmation, but understand the two Congressional Directed Spending requests submitted to Senator Collins were included in the Omnibus Bill approved in December by Congress. This will provide financial support for capital needs of the forest preschool program at the KCC, Seeds of Wonder, and our Community Outreach Liaison collaborative program with Kittery, Eliot and York Police Departments.

I have received confirmation from MDOT that decisions on the Bike/Ped Program Grant is due this month. The Town is still awaiting a decision on its grant application for \$400,000 (approximately 50% of the cost) for the Stevenson Sidewalk extension program.

Since January of 2022, the Town has successfully secured \$1,090,702 in grant funds for Kittery programs and operations, a 72.7% success rate. The Town has received \$2.73 in grant funds for every dollar match required.

We continue to pursue grants that align with Kittery's goals, objectives and needs. Identifying, applying for and administrating grants is a time-intensive effort. I am grateful for the amazing work our various departments have done in seeking and growing our grant supported efforts.

- 4. New Town Hall and KRRF Hours** – As a quick reminder, the Town began observing new customer service hours for the Town Hall and Kittery Resource Recovery Facility on January 3rd. These new hours are the result of the recruitment and retention work developed collaboratively with staff at the direction of Council. There is no change in the Kittery Community Center hours or the Rice Public Library hours.

The Freebie Barn is a volunteer-operated program and requires engaged citizens like YOU to help make it a success.

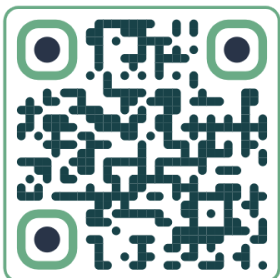

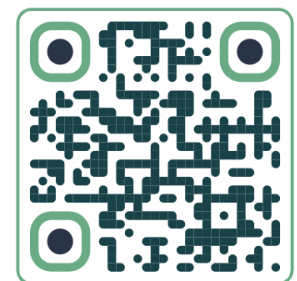

Title 30-A: MUNICIPALITIES AND COUNTIES

§2605. Conflicts of interest

1. Voting. The vote of a body is voidable when any official in an official position votes on any question in which that official has a direct or an indirect pecuniary interest.

4. Direct or indirect pecuniary interest. In the absence of actual fraud, an official of a body of the municipality, county government or a quasi-municipal corporation involved in a question or in the negotiation or award of a contract is deemed to have a direct or indirect pecuniary interest in a question or in a contract where the official is an officer, director, partner, associate, employee or stockholder of a private corporation, business or other economic entity to which the question relates or with which the unit of municipal, county government or the quasi-municipal corporation contracts only where the official is directly or indirectly the owner of at least 10% of the stock of the private corporation or owns at least a 10% interest in the business or other economic entity.

When an official is deemed to have a direct or indirect pecuniary interest, the vote on the question or the contract is not voidable and actionable if the official makes full disclosure of interest before any action is taken and if the official abstains from voting, from the negotiation or award of the contract and from otherwise attempting to influence a decision in which that official has an interest. The official's disclosure and a notice of abstention from taking part in a decision in which the official has an interest shall be recorded with the clerk or secretary of the municipal or county government or the quasi-municipal corporation.

A. This subsection does not prohibit a member of a city or town council or a member of a quasi-municipal corporation who is a teacher from making or renewing a teacher employment contract with the municipality or quasi-municipal corporation for which the member serves.

6. Avoidance of appearance of conflict of interest. Every municipal and county official shall attempt to avoid the appearance of a conflict of interest by disclosure or by abstention.

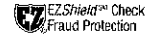

Subject: Title 10 – Badgers Island West Parking
Council Sponsor: Chairperson Judy Spiller

OVERVIEW

The Town received a number of parking congestion complaints from residents of Badgers Island West in November. The primary concerns raised by complainants was the effect on-street parking was having on the entrance to Badgers Island West, making it too narrow for larger vehicles, trucks, and public safety apparatus (fire trucks).

Upon receiving the complaints, we scheduled a site walk with the neighborhood to learn more about the challenges and discuss possible solutions. Postcards were sent to all of the property owners and businesses about the site walk.

On December 20, 2022, the Police Chief Richter, Fire Chief O'Brien, and I met with the residents and businesses of Badgers Island West. Approximately 25 people attended. We also received a few emails from those unable to attend in person. We discussed the primary concern area, then walked the entire street to discuss other areas and concerns.

There was consensus that restricting parking to the utility pole located approximately 250 feet into Badgers Island West was reasonable and acceptable to address the primary concerns.

**TITLE 10
PARKING RESTRICTIONS
BADGERS ISLAND WEST**

1. ADD to Title 10 Prohibited Parking a section of Badgers Island West as follows:

§ 10.3.1.1 Prohibited at all times.

Parking is prohibited at all hours in the following locations:

1 **AN ORDINANCE** relating to the municipality's authority for Town governance to give due and
2 proper attention to its many demands pursuant to the Town Charter, Federal law, and Maine
3 Revised Statutes, and more particularly where set forth in Maine Revised Statutes Title 30-A,
4 Municipalities and Counties.

5 **WHEREAS**, the Kittery Town Council is authorized to enact this Ordinance, as specified in
6 Sections 1.01 and 2.07(3) of the Town Charter; 30-A MRS §3001, pursuant to its powers that

8 morals, and safety, and does not intend for this Ordinance to conflict with any existing state or
