#### Control of Dogs at Public Parks

Limits the number of dogs one person is responsible for at a time, and the number of dogs one person can have off leash and under voice control at a time, while on public property. It is expected these limitations should help reduce the number of incidents of unwanted dog contact and uncollected dog waste at our parks.

#### Prohibition/Restrictions of dogs at various parks

Multiple options were given for the Council to consider regarding dog access at popular parks. They ranged in impact/restrictiveness and were proposed to facilitate discussion.

The proposal includes requiring dogs to be leashed at all times at Rogers Park which is the site of our outdoor preschool program. The proposal expressly prohibits dogs on all playing fields in Kittery.

The staff recommend having consistent regulations for Fort Foster and Seapoint and Crescent beaches to avoid confusion.

The current version represents edits agreed to at the Council Workshop on August 17, 2020. An additional edit was made to try to ensure clarity that a dog under Voice Control as defined in the ordinance is not "at large".

#### Welfare

ACO Byrnes has noted that state statute already grants him authority to address animal welfare relative to prolonged tethering and animals exposed to prolonged weather conditions. However, two Councilors expressed interest in having the ordinance cover animal welfare/cruelty.

#### **Fines**

Focuses on a single rate for the fine rather than a graduated approach for all violation except disturbing the peace. The ACO would also like codified that he can issue a No Trespass order to address repeat offenders.

#### Other Titles

Refers animal control back to Title 6 for Fort Foster, Seapoint and Crescent Beaches, and Town Farm. Rogers Park already refers directly back to Title 6.1. The proposed also corrects the Title of Town Farm to Town Farm Forest (unrelated to animal control).

#### **Public Comment**

Due to COVID related precautions on in-person Council meetings, the Town has been receiving written public comment for Council meetings and public hearings through its "Town Comments" email. Attached are the comments received from June through September 3. Any additional comments received by noon of September 9 will be uploaded to the online packet prior to the public hearing.

In reviewing the comments, a few patterns appear to emerge. Based on a high-level scan of the comments, approximately:

- 33% are solely expressing opposition to "banning dogs" at Seapoint and/or Fort Foster. Generally, there was no reference in the comments to Kittery's existing animal control ordinances or the proposed ordinance amendments being considered.
- 28% oppose "banning dogs" at Seapoint and/or Fort Foster and recommend existing ordinances remain unchanged.
- 37% oppose "banning dogs" at Seapoint and/or Fort Foster and encourage the Council look at enacting "other" restrictions instead. The specific comments ranged from proposing:
  - o restrictions currently in place
  - o the restrictions currently being considered by the Council
  - o different restrictions than currently being considered by the Council
  - o waste receptacles
- 2% vary including supporting "banning dogs" at Seapoint and/or Fort Foster, and other related or unrelated animal control topics.

The comment analysis was not in depth and involved scanning the text of the comments and attempting to sort them into a few broad categories:

- General "don't ban dogs"
- Keep Current Restrictions
- Consider Different Restrictions
- Other

The purpose of the analysis was simply to provide some at-a-glance info that may be useful as the Council considers each comment specifically.

#### PROPOSED SOLUTION/RECOMMENDATION

Hold a public hearing on the amendments and determine which amendments proposed are acceptable to the community for approval.

# Title 6 Animal Control

#### **AMEND Title 6 as follows:**

- 1 Title 6.1 **Dogs**Animal Control
- 2  $\S 6.1.0 1$  Conflict with other laws.
- 3 If in conflict with any section of this chapter, the provisions of Chapter 12.4 (Seapoint/Crescent
- 4 Beaches) or Chapter 12.5 (Fort Foster) will apply. In the event of any conflict in the provisions of this
- 5 article with the provisions of any present or future statute relating thereto, the most restrictive or that
- 6 imposing the higher standards governs.
- 7 § 6.1.**1**-2 **Definitions.**
- 8 For the purpose of this chapter, the following terms shall have the meanings ascribed to them in this
- 9 section.
- 10 **ANIMAL CONTROL OFFICER** Includes municipal police officer.
- 11 **AT LARGE** Off the premises of the owner, unless:
- 12 A. Controlled by a leash, cord or chain of not more than eight feet in length;
- B. Within a vehicle or under restraint in an open vehicle being driven or parked on a public way; or
- 14 C. Under the control of a person whose personal presence and attention would control the conduct of
- the dog. Voice Control.
- 16 **LEASH** A cord or chain not more than 10 feet in length.
- 17 **OWNER** Any person keeping or harboring a dog or other animal.
- 18 **PET** Any animal domesticated to serve as a companion, excluding service dogs.
- 19 **RESPONSIBLE PARTY** Any person who has possession, custody, or control of an animal.
- **VOICE CONTROL** An animal under control of the responsible party by voice command such that the
- 21 animal returns immediately to the responsible party upon calling, and remains by their side and in sight.
- 22 § 6.1.2-3 Applicability to visiting nonresidents License required.
- No dog may be kept within the Town unless licensed by its owners in accordance with applicable state
- 24 statutes. The licensing provisions of this chapter do not apply to any dog belonging to a nonresident
- 25 visiting within the Town without the intention of becoming a resident, but the owner of such dog must
- 26 comply with the remaining provisions of this chapter.
- 27 Proof of current dog license must be provided to the animal control officer upon request.
- §6.1.4. Control of pets on public property.
- A. No pet is allowed to be at large, as defined above, on any public property, or on private property
- without the consent of the property owner. This section does not prohibit the owner from using a

- dog for hunting, where hunting is permitted, provided the dog is under the voice control of its owner.
- 32 B. No dog is allowed to approach within ten (10) feet or have contact with of any person other than the

- § 6.1.5 **Menacing activity.**
- The owner of the animal not confined on private property or not in a vehicle may not permit that animal
- 59 to menace or bite any person.
- 60 § 6.1.<del>3-6</del> Right of entry to inspect-license, dog.
- For the purpose of discharging the duties imposed by this chapter and to enforce the provisions of this
- chapter, any the animal control officer is empowered, with the consent of the owner or occupant thereof,
- 63 to enter upon any premises on which an <del>dog</del> animal is kept or harbored, and to demand the exhibition by

- lower, or 95 degrees Fahrenheit or greater, for more than 30 minutes, unless otherwise permitted by state
- 126 law.
- 127 § 6.1.14 **Feral Cats**
- No person may feed or shelter a feral cat or feral cat colony.
- 129 A person found providing food or shelter for a feral cat will be deemed the responsible party of that cat

- With the exception of dogs, no domestic animals are allowed in Fort Foster Park, and dogs are subject to
- Town Code 6.1 Animal Control. the following conditions:
- 160 A. Dogs must be leashed at all times during park hours (10:00 a.m. to 8:00 p.m.) on weekends in May-
- and September and every day from Memorial Day to Labor Day, inclusive. A maximum leash of

- 177 Map No. 48, Lot No. 7] and includes all land bounded within the following: on the north and west

- 195 This chapter is enforced by the Police Department. The Conservation Commission is responsible for the
- management of the Town Farm forest Forest in accordance with the Town Farm forest Forest
- management plan duly adopted by the Town Council.

#### Chapter 6.1

#### **DOGS**

#### § 6.1.0. Conflict with other laws.

If in conflict with any section of this chapter, the provisions of Chapter 12.4 (Seapoint/Crescent Beaches) or Chapter 12.5 (Fort Foster) will apply.

#### § 6.1.1. Definitions.

For the purpose of this chapter, the following terms shall have the meanings ascribed to them in this section.

ANIMAL CONTROL OFFICER — Includes municipal police officer.

AT LARGE — Off the premises of the owner, unless:

- A. Controlled by a leash, cord or chain of not more than eight feet in length;
- B. Within a vehicle or under restraint in an open vehicle being driven or parked on a public way; or
- C. Under the control of a person whose personal presence and attention would control the conduct of the dog.

OWNER — Any person keeping or harboring a dog.

#### § 6.1.2. Applicability to visiting nonresidents.

The licensing provisions of this chapter do not apply to any dog belonging to a nonresident visiting within the Town without the intention of becoming a resident, but the owner of such dog must comply with the remaining provisions of this chapter.

#### § 6.1.3. Right of entry to inspect license, dog.

For the purpose of discharging the duties imposed by this chapter and to enforce the provisions of this chapter, any animal control officer is empowered, with the consent of the owner or occupant thereof, to enter upon any premises on which a dog is kept or harbored and demand the exhibition by the owner of the dog and the license of such dog.

#### § 6.1.4. Hindering officers, improperly releasing dogs prohibited.

No person may interfere with, hinder or molest any animal control officer in the performance of the officer's duty or seek to release any dog in the custody of an animal control authority, except as provided in this chapter.

#### § 6.1.5. Record to be kept by animal control officer; contents.

It is the duty of an animal control officer to keep, or cause to be kept, an accurate and detailed record of the licensing, impoundment and disposition of all dogs coming into the officer's custody.

#### § 6.1.6. License required.

No dog may be kept within the limits of the Town unless such dog has been licensed by its owner in accordance with the statutes of the state.

#### § 6.1.7. Impoundment authorized.

Unlicensed dogs, wherever found, or dogs found running at large will be taken by an animal control officer and impounded in an animal shelter. Such animal may be confined for a period of not fewer than 10 days unless earlier reclaimed under the provisions of § 6.1.9.

#### § 6.1.8. Impoundment fees.

Any dog impounded in accordance with this chapter may be reclaimed upon payment of the total fees for board. This fee is paid to the keeper of the animal.

# § 6.1.9. Disposition of impounded dog, notification of impoundment.

- A. A dog owner may reclaim an impounded dog upon compliance with § 6.1.6 and upon payment of the boarding fees set forth in § 6.1.8. Any dog impounded under the provisions of this chapter and not claimed by the owner within the ten-day period is considered abandoned by the owner and the property of the animal shelter. The dog may be given, after consultation with the Humane Society and/or the Animal Refuge League, to the Humane Society or the Animal Refuge League or to any person deemed to be responsible and a suitable owner, who will agree to comply with the provisions of this chapter or humanely destroy the animal.
- B. Where the ownership of an impounded dog is known, or can be reasonably ascertained by an animal control officer, such officer shall, if possible, notify the owner within three days of such impoundment, but failure to give such notice does not impose any liability upon the Town for the destruction or transfer to another of any dog so impounded and not reclaimed within the required period.

#### § 6.1.10. Disposition of dog biting person.

Whenever any dog bites a person, the owner of such dog must immediately notify an animal control officer, who may order the dog held on the owner's premises or have it impounded for a period of two weeks. The dog must be examined immediately after it has bitten any person and again at the

end of the two-week period. If at the end of the two weeks a veterinarian is convinced that the dog is then free from rabies, the dog is released from quarantine or from the pound, as the case may be. If the dog dies within the period, its head must be sent to the State Department of Health for rabies examination.

#### § 6.1.11. Disturbing the peace.

No person owning any dog may suffer or permit such dog to disturb the peace and quiet of the neighborhood by continuous barking, by making other loud or unusual noises, or by running through or across cultivated gardens or fields.

#### § 6.1.12. Running at large prohibited.

No dog is permitted to run at large within the limits of the Town; however, this section does not prohibit the owner of a dog from using such dog for hunting, provided the dog is under the control of its owner.

#### § 6.1.13. Animal waste.

It is a violation of this chapter for any owner of a dog to fail to remove and properly dispose of feces left by his or her dog(s) on any improved portion of public ways or sidewalks.

#### § 6.1.14. Violations and penalties.

Any violation of this chapter will be assessed a penalty under Title 1, Chapter 1.3.

#### Chapter 12.3

#### **ROGERS PARK**

#### § 12.3.1. Title.

The ordinance codified in this chapter is known as "Rogers Park."

#### § 12.3.2. Purpose.

- A. It is the purpose of this chapter to preserve the natural character and beauty of Rogers Park. Let it be known henceforth and forever that the people of Kittery set aside this parcel of land as an area to enjoy nature and promote the protection of wildlife and unique species of vegetation that inhabit the area, to be preserved for future generations for the common good.
- B. Rogers Park means the two plots of land, consisting of approximately 27 acres and known today as "Rogers Park," that were deeded September 30, 1958, to the "Inhabitants of the Town of Kittery" for the

consideration of \$1 by Richard J. Rogers, Esther F. Hibbard, Helen W. Johnson, and Charlotte S. McClintock.

#### § 12.3.3. Restrictions.

- A. No person may remove, injure or otherwise damage or deface any thing, plant material, sign, marker, bench or structure within Rogers Park. The disposition of any artifact found within the park is determined by the Town Council. Use of metal detectors or similar devices is prohibited. "Paint-ball" activities and materials are prohibited.
- B. Littering is prohibited. A carry-in, carry-out policy is in effect.
- C. Control of dogs is governed by Chapter 6.1 of the Code.
- D. No person may start or allow to burn any fire within the bounds of Rogers Park.
- E. Excepting the designated area, no motor vehicles are allowed except in conformance with Chapter 12.8.
- F. No person may engage in indecent conduct within Rogers Park. As used in this section, "indecent conduct" is defined as set forth in Title 17-A, § 854 of the Maine Criminal Code.
- G. No person may drink or consume any alcoholic, spirituous, vinous, fermented or other alcoholic beverage, or combination of liquors and mix liquors within the bounds of Rogers Park. No person may possess or consume any illegal drug within Rogers Park.
- H. Camping is prohibited from 12:01 a.m. to 6:00 a.m., unless permitted by the Town Council.

#### § 12.3.4. Enforcement.

This chapter is enforced by the Police Department. The Kittery Conservation Commission is responsible for the management of Rogers Park.

#### § 12.3.5. Violations and penalties.<sup>2</sup>

Any violation of this chapter will be assessed a penalty under Title 1, Chapter 1.3. All penalties recovered accrue to the benefit of the Town.

#### Chapter 12.4

#### SEAPOINT AND CRESCENT BEACHES

#### § 12.4.1. Definitions.

As used in this chapter, the following terms shall have the meanings indicated:

CRESCENT BEACH — Includes all land bounded within the following: south and east by the Atlantic Ocean, northerly by the salt marsh and Seapoint Beach and westerly by other owners.

SEAPOINT BEACH — Includes all land bounded within the following: on the south and east by the Atlantic Ocean, on the north by the land now or formerly of Albert Kerr, on the west by the salt marsh, other owners and the easterly edge of Cutts Island Road. Seapoint Beach includes that area known as Thaxter's Point.

#### § 12.4.2. Disorderly conduct.

No person may engage in disorderly conduct within Seapoint or Crescent Beach. Disorderly conduct as used herein includes but is not limited to the making of loud and unreasonable noises; the activating of any device or explosive substance which releases noxious or offensive odors; knowingly accosting, insulting, taunting or challenging any person with offensive, derisive or annoying words or gestures, or other physical conduct which would in fact have a direct tendency to cause a violent response by an ordinary person in the situation of a person so accosted, insulted, taunted or challenged.

# § 12.4.3. Vehicular use; parking restrictions. [Amended 9-26-2011 by Ord. No. 11-12; 10-23-2017 by Ord. No. 17-15]

No person may drive or park any motor vehicle other than an authorized vehicle on Seapoint or Crescent Beaches, shore or bank. No bus may be operated, driven or parked anywhere within the area defined as Seapoint and Crescent Beaches.

A. Parking in all designated parking areas for Seapoint and Crescent Beaches is available for Town residents and nonresidents in accordance with Title 10 of Town Code.

#### § 12.4.4. Indecent conduct.<sup>3</sup>

No person may engage in indecent conduct within Seapoint or Crescent Beaches. As used in this chapter, "indecent conduct" is defined as set forth in Title 17-A, § 854 of the Maine Criminal Code.

#### § 12.4.5. Littering.

No person may throw, drop, deposit, discard or otherwise dispose of litter within Seapoint and Crescent Beaches except in a litter receptacle.

#### § 12.4.6. Disturbing topography.

No person may remove, molest, injure or otherwise damage anything natural or physical within Seapoint and Crescent Beaches. This provision is not intended to regulate the removal of seashells and driftwood, seaweed and scientific samples.

#### § 12.4.7. Drinking.

No person may drink or consume any alcoholic, spirituous, vinous, fermented or other alcoholic beverage, or combination of liquors and mix liquors upon Seapoint and Crescent Beaches.

#### § 12.4.8. Animals.

- A. No domestic animal is allowed within Seapoint or Crescent Beaches, except that dogs, while under the control of their owner or keeper, are allowed on Crescent and Seapoint Beaches at times other than between the hours of 10:00 a.m. to 5:00 p.m. from June 15 through September 10 of each year. This limitation does not apply to guide or seeing eye dogs when used as such. At no time may the owner or keeper of any dog allow that dog to run at large on Crescent or Seapoint Beaches or enter upon any publicly owned salt marsh immediately adjacent to Seapoint or Crescent Beach. From May 15 to September 30, inclusive, only dogs licensed to Town residents are allowed on Seapoint and Crescent Beaches.
- B. A pooper-scooper rule is in effect for dogs. Owners and keepers must properly dispose of animal waste either by placing it in supplied receptacle(s) or, if one is not supplied, by taking it with them when leaving the beaches.

#### § 12.4.9. Fires.

No person may start or allow any fire to burn within Seapoint or Crescent Beaches except in suitable facilities provided by the municipality or where permission has been obtained from the municipal Fire Chief, Town Forest Fire Warden. A permit will not be required for the use of portable stoves which are fueled by propane gas, sterno or briquettes. In the event that any cooking or other fire or burning herein allowed is undertaken by any person, said person before leaving such fire must totally extinguish the same.

#### § 12.4.10. Entering upon salt marsh.

A. No person may trespass or enter upon the publicly owned salt marsh immediately adjacent to Seapoint or Crescent Beaches except for educational or scientific purposes and only after approval is granted by the Town Council or its duly designated agent(s). Requests may be made to the Town Clerk, who is to refer all such requests to the Town Council or its duly designated agent(s).

B. Public notice is to be given by locating signs conspicuously along the salt marsh, notifying the public of this limitation.

#### § 12.4.11. Windsurfers prohibited.

No person may engage in windsurfing in the waters of Crescent and Seapoint Beaches between June 15 and September 10 of each year except in those areas duly authorized and designated by the Town Council. Public notice of such designated areas is to be conspicuously posted in the beach parking lot or other conspicuous place or places.

#### § 12.4.12. Jet skis prohibited.

Jet skis are prohibited on the shore or in the waters of Crescent and Seapoint Beaches.

#### § 12.4.13. Selling prohibited.

The selling of merchandise or services is prohibited at Seapoint and Crescent Beaches.

#### § 12.4.14. Camping prohibited.

Camping is prohibited from 11:00 p.m. to 6:00 a.m.

#### § 12.4.15. Hours of operation.

- A. Seapoint and Crescent Beaches and all parking areas are closed to the general public between the hours of 11:00 p.m. and 3:00 a.m., with the exception of vehicles used in their official capacity by agents or employees of:
  - (1) The Town;
  - (2) Public utilities:
  - (3) Emergency services; and
  - (4) Contractors providing service to or on behalf of the above.
- B. The owners or operators of any motor vehicles found in violation of this section will be summoned, and the vehicle will be towed at the owner's expense, as provided in § 10.3.11.

#### § 12.4.16. Beach closure.

The Town Manager is authorized to close the beaches to bathing when quality testing determines the water to be unhealthy for humans. The enforcement and penalty portion of this chapter does not apply to this section.

#### § 12.4.17. Enforcement; violations and penalties.

This chapter is enforced by the Police Department. Any violation of this chapter will be assessed a penalty under Title 1, Chapter 1.3. All penalties recovered accrue to the benefit of the Town.

#### Chapter 12.5

#### FORT FOSTER

#### § 12.5.1. Animals.

With the exception of dogs, no domestic animals are allowed in Fort Foster Park, and dogs are subject to the following conditions:

- A. Dogs must be leashed at all times during park hours (10:00 a.m. to 8:00 p.m.) on weekends in May and September and every day from Memorial Day to Labor Day, inclusive. A maximum leash of eight feet is allowed.
- B. While under control of the owner or keeper, dogs are also allowed in the park during the following days and times:
  - (1) During weekdays, prior to Memorial Day in May;
  - (2) Before park opening (sunrise to 10:00 a.m.) between Memorial Day and Labor Day;
  - (3) During weekdays, after Labor Day in September; and
  - (4) Between sunrise and sunset from October 1 to April 30, inclusive.
- C. A "pooper scooper" rule is in effect for dogs. Owners or keepers must take their dogs' solid waste with them when leaving the park.

#### § 12.5.2. Beach closure.

The Town Manager is authorized to close the beaches to bathing when quality testing determines the water to be unhealthy for humans. The enforcement and penalty portion of this chapter does not apply to this section.

### § 12.5.3. Enforcement; violations and penalties.<sup>4</sup>

This chapter is enforced by the Police Department. Any violation of this chapter will be assessed a penalty under Title 1, Chapter 1.3. All penalties recovered accrue to the benefit of the Town.

#### Chapter 12.7

#### **TOWN FARM**

#### § 12.7.1. Title.<sup>5</sup>

The ordinance codified in this chapter is called the "Town Farm Ordinance."

#### § 12.7.2. Purpose.

- A. It is the purpose of this chapter to preserve the natural character and beauty of the forest at the site of the former Town farm. It is also the intent that John R. Haley's gift to the people be used for the good of all in his honor, as his will's intent to do good for the people is evident. Let it be known that henceforth and forever the people of Kittery set aside this parcel of land as an area to enjoy nature, to be preserved for future generations for the common good.
- B. "Town Farm" means the site of the former Town farm at 77 Haley Road (see Kittery Tax Map No. 48, Lot No. 7] and includes all land bounded within the following: on the north and west by the land now or formerly of David E. and Ann E. Blake, Harold L. Durgin Trust, Hilda M. Wilson and Brenda E. Lawrence and Lynda W. Clark and Jefferson L. Wilson; on the south and east by land now or formerly of Eugene and Hildred C. Lewis and the estate of Marion F. Lewis; excepting the Central Maine Power Company power line easement going through the property.

#### § 12.7.3. Restrictions.

- A. No person may remove, injure or otherwise damage or deface any thing, plant material, sign, marker, bench or structure within the Town Farm. Use of metal detectors or similar devices is prohibited. "Paintball" activities and materials are prohibited.
- B. Littering is prohibited. A carry-in, carry-out policy is in effect.
- C. Control of dogs is governed by Chapter 6.1. Dogs must be on a leash at all times unless under the control of the owner or keeper. This limitation does not apply to service dogs when used as such.
- D. No person may start or allow to burn any fire within the bounds of the Town Farm.
- E. No motor vehicles are allowed except in conformance with Chapter 12.8.
- F. No person may engage in indecent conduct within the Town Farm. As used in this section, "public indecency" is defined as put forth in Title 17-A, § 854 of the Maine Criminal Code.
- G. No person may drink or consume any alcoholic, spirituous, vinous, fermented or other alcoholic beverage, or combination of liquors and mix liquors within the bounds of the Town Farm.

H. Camping is prohibited from 12:01 a.m. to 6:00 a.m., unless permitted by the Town Council.

#### § 12.7.4. Hunting.

Signage will be posted at the entrances, stating that hunting is allowed.

#### § 12.7.5. Enforcement.

This chapter is enforced by the Police Department. The Conservation Commission is responsible for the management of the Town Farm forest in accordance with the Town Farm forest management plan duly adopted by the Town Council.

#### § 12.7.6. Violations and penalties.<sup>7</sup>

Any violation of this chapter will be assessed a penalty under Title 1, Chapter 1.3. All penalties recovered accrue to the benefit of the Town.

#### Good evening,

I am commenting on the proposed changes to the animal control regulations in Kittery. I have lived here for five years upon retiring. While I am an animal lover, I do favor a restriction on permitting animals at recreation areas during the prime hours of use. One of my primary reasons for selecting Kittery was its beautiful beach and park areas.

My concerns are twofold. First, the requirement that animals be kept on a leash at all times is not always followed. As someone who has been bitten by dogs many times, I find myself becoming very fearful when I see an off leash dog in the area. The actual size of the animal is not my concern; it is simply the fact that animals may react to sounds or sights and attack without provocation, even if they normally are not prone to do so. Animals are animals and we cannot predict or manage their innate behaviour.

My second concern is a health and safety issue. It is very disheartening to see the feces very often left behind by animals. Owners at a beach or park typically do not even attempt to clean up waste, leaving it for others to deal with. There are many pictures on local community group pages showing the efforts of volunteers to clean up waste which should not have been permitted in the first place.

Having our animal control officers constantly cleaning and patrolling is a waste of our tax dollars. It is best to eliminate the problem at the start.

I suggest that dog parks are the most appropriate places for dogs to be allowed off leash. This is the most common protocol in most communities. It removes the risk of animal attacks, as well as limiting the area of waste to be remediated.



I am writing as a resident of Kittery who was born in Kittery, currently owns two houses here and has convinced 3 of my friends (2) of whom have dogs) to buy homes in Kittery. I am very invested in this town and love it a WHOLE LOT. I am writing to request a couple of simple things. Beyond these couple of requests I have included some comments on some of the proposed changes after reading through them thoroughly and giving it lots of thought.

The two things I am writing to you to request are:

- 1. A respectful, civil, and open-minded dialogue regarding this issue, that incorporates facts/data and personal experiences (this should be the approach to all issues, really!)
- 2. Prioritizing solutions that are inclusive, well thought out, and not based on 1 or 2 peoples (residents and/or town council members) own opinions, experiences or views.

You, as town council members, are elected to represent us, the residents of this town, and to serve us and the town as a whole (individuals, businesses, the gorgeous land and water areas, our animals, and the folks who visit our town for any variety of reasons, etc.) You are not elected to our town council to push your own agendas.

#### MAIN RECOMMENDATION:

Please maintain a space in Kittery where dogs can be off leash and socialize with each other at least some days or hours of the day. Humans are social beings and so are dogs. It is wonderful to have a space where we can be together. Dogs also do much better when they can socialize. Some of the dogs with behavioral issues are that way because they were not properly socialized. We can do this while also having spaces that are human only, AND other spaces where dogs are on-leash and/or humans who don't want to be around dogs know that there are hours when dogs are allowed and hours when dogs are not. I think the hours at Seapoint are great! I sometimes leave my dog at home and go to Seapoint or Fort Foster without them because I want to enjoy that space without a dog around. I am thrilled for other people to be able to have a peaceful time at the beach without dogs. I am also thrilled to be able to go earlier in the morning or in the evening and let my dog run and socialize or to have spaces at Fort Foster designated for dogs or no dogs during their open season. Keeping my dog on leash at every public space actually increases the likelihood of incidents as dogs tend to be more protective of owners when on-leash and can get tangled with other dogs. Please have some off leash space and time for dogs with signs clearly stating those times so that everyone knows the rules and what to expect when entering that space. I propose some ideas below.

- 35 C. Owners must immediately collect and properly dispose of or secure feces left by their dog(s) on any improved portion of public ways or sidewalks, and in public parks. Owners or responsible parties must maintain possession of their dog's feces while on public property.
- Local businesses are working on sponsoring trash cans at these sights. This is how much we love Kittery and love having places to be with our dogs and each other in Kittery. If we work on addressing these issues collaboratively then we can all find common ground and ways that we can make some changes that allow for us solve the problems without going to

unnecessary extremes, without being hurtful to each other, and without alienating residents and visitors who pay taxes in Kittery and who spend money at local businesses partially because they can enjoy outings with their dogs here! I frequently take walks at Seapoint and at Fort Foster and the amount of dog poop bags I see left out is very minimal! I really think that providing some trash cans (again, even private citizens are willing to sponsor trash cans and trash pick up!) would help to further eliminate this issue.

38 D. No personresponsible party may have more than 1 dog under voice control at large on public property, at any time.

- Why not 2 dogs? Some people have 2 dogs (perhaps even some of the town council members) that have been raised together and are very well behaved together and actually keep each other in check or help to keep each other from bothering other humans.

40 E. No person may be a responsible party for more than 3 dogs at any time while in a Town park.

- What about professional dog walkers? There are professional dog walkers who manage more than 3 dogs as their business and could have 5 dogs, all on leash, and manage them all well.

45 H. Seapoint and Crescent Beaches 46 1. Dogs are prohibited, between the hours of 10AM and 5PM, between Memorial Day and Labor Day 47 inclusive. 48 2. Dogs must be on a leash between May 1 and September 30, inclusive.

- Why are we not allowing dogs off leash prior to 10am and after 5pm?

OR allow dogs off leash at Crescent beach only as it tends to have less people sitting or laying out. OR have dogs off leash at Seapoint/Crescent beach ONLY between September 30th and Memorial Day.

49 I. Rogers Park 50 1. Dogs must be on a leash at all times.

- Dogs must be on leash between 7am and 5pm and can be off leash after 5pm (the pre-school children are gone by then)

#### **OFF LEASH AREA/DOG PARK:**

Please have at least 1 location that allows dogs to be off leash for at least some hours of the day! If it is not going to be at any of these locations then lets create a fenced in dog park where this can happen. I recommend all town council members visit the dog park in Ogunquit. It is LOVELY and people are so friendly and gracious there and some folks have really invested in maintaining it beyond what the town even does. If Kittery were to create a space similar to this (large fencedin area with trees, wood chip covered ground, a couple of benches, a hose to fill water bowls, poop bags and a large trash can) then it would be acceptable to have the other sites be on leash.

CLEAR SIGNAGE at all sites (Rogers, Fort Foster, Seapoint, Town Farm Forest) Rules need to be posted more clearly in order to be enforced.

It is currently stated in the town regulations re: Seapoint and Crescent Beaches (Chapter 12.4) "From May 15 to September 30, inclusive, only dogs licensed to Town residents are allowed on Seapoint and Crescent Beaches." However, this is NOT stated on a sign at the beach.

I'm writing very much in support of Fort Foster beach and trails remaining dog friendly.

There have never been too many, or bothersome to me. Nor have I seen fights, or off leash dogs getting in the business of anyone. They are too busy enjoying themselves, like the rest of us.

I've never personally come upon dog poop on the beach (and I criss cross walk the length of it at low and high tides, so cover both the grassy/rocky areas as well as the shoreline), nor have I found abandoned bags of poop like I have seen elsewhere. It's pretty special to have the ability to bring your dog to a beach and I think people have been pretty conscientious at FF.

Lastly, I don't have a dog, so I am making this argument without any direct self-interest, save that seeing dogs on the beach, adds great joy and delight, watching their different shapes and sizes, how happy they are to be there. how they interact with their owners.

People need to take their dogs out, not just for the twice a day dutiful walk, but to feel some freedom and play, Fort Foster provides a SAFE place for families to do that. There are way too many dangerously small or winding roads in Kittery without sidewalks to limit people to that.

Also, dogs get their people out for fresh air, sunshine and exercise, and on the beach people get 10x the health benefits than they do when limited to their own yards, or the occasional dog parks, of which there are few...

As a Kittery Point resident dog owner I would like to voice my thoughts.

- I believe that 'leashed' restrictions should be in place for the high tourism summer months but should not be in place for the year round residents who rely on both Seapoint and Ft. Foster to keep their pets healthy.
- If extreme restrictions are put on how dog owners recreate on beaches, I am concerned where they will be displaced to. This may bring high traffic to areas such as Kittery Town Forest and other Land trust sites. This displacement is exacerbated by potentially confining individuals into much tighter spaces on single track trails which, given the current social distance guidelines, could be a negative consequence of shutting down beach opportunities.
- It is important to note the amount of revenue that dog owners bring to Kittery businesses. I personally know 6 families that travel from various parts of NH to recreate at Seapoint and Ft. Foster. The majority of whom, visit local spots for food and drink after the beaches.
- I believe that dog waste specific trash cans could resolve some of the problem of neglected bagged waste. This of course would require funding. Given the amount of resident dog owners in Kittery and the general affluent population, I would be happy to begin a 'Go Fund Me' page for waste removal.

Bottom line, put leashed restrictions on the high summer months of June-July but please keep in mind the year-round residents reliance upon keeping their pets (family members) healthy during the low density months.


As a frequent visitor to Fort Foster, I object to the initiative to ban dogs. There are so few places where people can bring their dogs to have space to explore, exercise, and socialize with other dogs. These are all important to teach and reinforce sociallyappropriate behavior in our companion animals. Rather than take this away from so many of us, perhaps a compromise can be reached? Perhaps limiting dogs to before 9 am and after 5 pm during peak months (say mid-June to mid-September), and allowing them without time restrictions the rest of the year? This is how dog access is handled on the beaches in Kennebunk, where I live, and while it doesn't please everyone, it's an effective compromise.

Several years ago, a group of Kennebunk residents pushed to have dogs banned from our beaches. In considering this, the town polled residents and visitors, and concluded the economic impact of banning dogs from the beach would be significant. Many visitors said that one of the major reasons they chose to vacation in Kennebunk was that they could bring their dog(s) to the beach (during seasonally-appropriate times). Ultimately, the town decided to keep the current dog ordinance in place, allowing them all day long from September 16 to June 14, and before 9am and after 5pm from June 15 to September 15, and placing numerous "doggie bag" dispensers along the beach for proper cleanup.

We love the beauty of Fort Foster, and having a grassy place to bring our dogs when we don't want them to get all sandy at the beach is very important to us. We love to pick up a bite at Beach Pea or Coco Loco, then head over to the Fort for a few hours of fresh air and relaxation, but we're not likely to do so if it means leaving our dogs alone at home; they are alone enough during the work week. Please reconsider your decision to ban dogs from there and other parks in Kittery; it will benefit very few, and displease many. Thank you.

#### Council Members.

We listened to the discussion during your Title 6 – Animal Control workshop on August 17. We appreciated Ms. Spiller's effort in trying to make these guidelines fair for both groups, i.e., "dog advocates and "no-dog advocates." Without question, both groups will have to make concessions.

In looking at your proposed changes for dogs at the town parks/beaches, "dog advocates" received the short shift. They lost the most time. During the October 16 to May 15, we can anticipate inclement weather (cold, rain, ice, and snow) for long period of time. Day light hours range from 11 hours to 8 hours. Some of the colder months, the sun rises after 8 a.m. and the sun sets time at 5 p.m. During these winter months, I have only seen dog walkers in the park. So, "no-dog advocates" have prime daylight time to enjoy the park. Do they pay more in taxes?

In the workshop discussion, Mr. Pelletier wanted to simplify the hours and not make the signs complicated. Well, this issue is complicated.

We certainly respect the previous rule "all dogs on a leash when the park was open" but do not accept "all dogs on a leash at all times." In looking at the packet for the council meeting, it still indicated "on leash" anytime a dog is allowed in the park or beach. From the discussion, there were council members (Judy Spiller, Matt Brock, Cyrus Clark) who advocated that at the designated times, dogs could be off leash if the pet was under control. Why was this not changed in the packet?

The council has not given specific data of negative or harmful of dog-related incidents other than anecdotal evidence or council members' own personal opinions. Without question, there are irresponsible dog owners who should be penalized. However, why should most dog owners who are very responsible be penalized for a few? Why cannot we take our well-trained dog off leash in the early morning or other times when there are few and sometimes no others in the park? We are responsible by thoroughly training our dog and picking up after her.

As elected officials, we expect council members to listen to all your constituents and not just two members who do not like dogs. We were appalled at one council member who said that if individuals do not have a sufficient yard space for a dog, they should not have a dog. Such an elitist statement! So, I guess he thinks only well-to do homeowners with land should have a dog.

If there is a problem, come up with alternative solutions other than dictating all dogs must always be on a leash. Look at the active Facebook account (ban the dogs or friends of Fort Foster), and you will see lots of ideas and recommendations including:

- 1. Allowing for off-leash dogs at both venues at selected and reasonable times;
- 2. Installing specialized trash containers at appropriate spots;
- 3. Placing more signs: and
- 4. Contracting for a disposal pick up.

Three of the recommendations could have an impact on the town's budget especially with the pickup and disposal. Before you automatically reject this idea, determine the exact cost. We do not think it would add a significant amount to the budget. Again, we and other Facebook contributors have ideas on how to generate possible income to offset the expense.

1. Adding fees or special permits for dog owners (both Kittery and non-Kittery residents). For your current (and unacceptable) options, Kittery would have to enforce those regulations. Having special permits, the same town enforcer could issue hefty fines to dog owners who do not have the special permit.

#### And/Or

2. Organizing a volunteer group who would work with the appropriate town committee to help resolve the problems. This group could raise funds to pay for added expenses by seeking donations from individuals and sponsorships from individuals and from dog-related businesses in Kittery, e.g., veterinarians or dog-training businesses and local composting businesses. I have learned through my community involvement that Kittery residents are extremely generous with their time and resources. Let the community help.

Cyrus Clark had an excellent recommendation during the workshop that was not discussed further. He said one of the problems is too many dogs. Many individuals who bring their dogs to Fort Foster are non-Kittery residents. Mr. Clarke suggested implementing a Kittery-only parking outside the gate of Fort Foster. This parking restriction could be the same length of road as the town has posted for the pandemic. Non-Kittery violators would be fined and thus generating revenue for the town.

We appreciate your services to Kittery. However, please recognize that these proposed changes will have a significant impact on many residents. Decisions like this require input from multiple groups to formulate a consensus as to what is best for Kittery. Kittery residents pay considerable amount of taxes and would certainly appreciate an opportunity to have input to a new rule that could adversely affect their life here in Kittery. Banning all dogs or even banning off-leash dogs all times would change the character of Kittery.

# Comments on Fort Foster dog restriction for August 17 Town Council Workshop

#### To Whom It May Concern:

This email is intended to share my comments on the proposals regarding dog restrictions at Fort Foster in advance of the Town Council's August 24th meeting. I am not a Kittery resident (I live in Portsmouth), but I visit Fort Foster multiple times a week and hold a 2020 season pass. I am strongly opposed to restricting dog access altogether to Fort Foster during the day (10am-5pm), as well as limiting off-leash times at night, because they unfairly discriminate against good dog owners and limit the park's unique accessibility to all.

When I first moved to NH, one of the first things I did was find a place I could regularly take my dog for exercise - I ended up at Fort Foster, which we have both grown to love. The park is stunningly beautiful, but it is also accessible for all - an all-too-rare attribute in New England. During my visits, I always take doggie bags with me (at least 3 so I have extra), pick up any refuse produced by my pet, and carry it around with me until I return to my car. And while I have observed the occasional "left behind" dog bag (alongside litter from humans), I have never observed a dog owner who did not pick up after their dog. In my experience, other dog owners are like minded and appreciative of how special and rare Fort Foster is for ourselves and our pets. In fact, one of the things I loved most about visiting Fort Foster (especially as a newcomer to New England) is the introduction it provided to a community of kind and friendly fellow dog owners - people I would never have otherwise met. Over the past several months, safe, affordable activities like this have only become more rare and important for me and many others.

While the Town Council may already be aware of these issues, I want to share my personal perspective on the broader economic and social consequences of both Option A and B. First, to be clear, I will not spend money on day passes or a season pass to Fort Foster if I cannot bring my dog. Especially in these current socially distanced times, my exercise always includes my pet - if I cannot take him, I will seek other locations where I can bring him. For the town of Kittery, lost revenue from fees to Fort Foster is likely to be felt more broadly - indeed, I almost always combine my visits to Fort Foster with a visit to Kittery bakeries, coffee shops and restaurants (Lil's Cafe, Beach Pea Bakery, Tulsi, Anju, Pepperrell Cove, etc. - all locally owned businesses). This is money that I will spend in my own Portsmouth, NH community if I cannot go to Fort Foster. And lastly, I want to note that I am concerned about the heightened public health threat of visits to the few dog friendly places that remain if Fort Foster restricts access. Allowing dogs in Fort Foster undoubtedly encourages their owners to get out and exercise themselves, but it also decreases the density of people in other dog friendly places -- especially important in the current socially distanced times.

I understand the Town Council's concerns and would recommend a few other alternative suggestions to address the issues raised by dogs:

- Install stations with doggie bags and/or small bins for dog refuse at the large parking lots. Fees for the installation of such items would be collected via a "dog season pass" available in the same manner as a normal vehicle-linked season pass.
- I am also not opposed to broadening leash requirements during the on-season (as is practiced right now). In fact, in the two years that I've been going to Fort Foster, I rarely let my dog off-leash because other people (especially families with young children) are often unaware of the rules in the off-season (or before 10am) and I would not want them to be surprised by my very friendly golden retriever. Alternatively, you might consider requiring dog owners to submit a letter from their vet, dog trainer, boarding facility, or other licensed individual who can certify that the dog is non-aggressive. As you are already required to submit a vehicle registration certificate to purchase a season pass, this would not be unreasonable or difficult to institute as part of the online application.



### Comments to the town council



I'm a resident of Kittery and am writing about a possible permanent ordinance that would require dogs be leashed at all times. Our chief of police in late 2019 stated that the number of dog calls and complaints had diminished over the previous few years. Before the town drafts new ordinances making stricter laws against dogs and their owners, shouldn't the town demonstrate a growing problem that needs to be addressed?

But, I do agree that there are a few bad dog owners. And a few vocal people who use this as their justification to push to enact ordinances that would restrict our dogs to leashes at all times. This is an emotional, rather than a logical response. For example, alcohol use creates more societal issues than any benefit it gives. So perhaps we should ban alcohol. While we're at it, ban all teenage drivers, elderly drivers. Ban motorcycles, bicycles, skateboards. My point is that society does not outlaw much that may be problematic and even dangerous. That's where education, clear ordinances with clear and consistent signage, and enforcement would come in.

Fort Foster has been free to walk-in residents and non-residents alike when closed: people often undervalue something they don't have to pay for or put any effort into. There have been so many mornings of twenty plus cars (sometimes many more) parked outside the gate without a Fort Foster sticker, never ticketed. Are they even aware of the rules and that there have been problems? I've had discussions with dog owners who insisted that their dog's poop at the side of the path was fine – that they only had to pick up poop that was actually in the path. A dog pass with a contract spelling out the owner's responsibilities would be a good step toward awareness – the cost of the pass would pay for the cost of implementing such an idea. The fear of the pass being revoked for the season or forever would help with compliance.

So many of us love walking our dogs early mornings on the beach and at the Fort. It's our community and it's a big community. Many, many of us pick up poop bags left behind (and other trash) and scoop poop. Almost all of us have well behaved dogs and and we pay attention. Many of us recognize what we could lose and have actively promoted responsible behavior at the beach and the Fort.

Requiring leashes 24/7 is addressing the issue with a sledgehammer and it penalizes all law-abiding dog owners. There are good solutions out there besides mine, just look at the great suggestions from the Parks Commission, let's consider them. Thanks. –Jenny Freeman

## Proposed Dog Ordinance: Title 6

I am writing to make sure that when the hands are counted on the issue of Kittery remaining a dog-friendly community, that my voice was heard. As a thirty+ year tax-paying citizen of Kittery I am in favor of Kittery remaining a dog-friendly community, as it has always been.

As it is currently written Title 6 is too restrictive and onerous. It was written as if dog owners are the enemy and all dogs are out of control. I would take issue with many components of the ordinance as written. For example, banning dogs from our spaces in summer or requiring them to be leashed at all times as well as the requirement for dogs to always be on leash at Rogers Park. Additionally, provision 6.1.4 D "No responsible party may have more than 1 dog under voice control at large on public property, at any time." That is unworkable for those of us with two dogs. Dogs socialized to play together. That is just not reasonable. Other provisions seem to adequately address the challenge of professional dog walkers roaming our parks with packs of dogs. Two dogs are not a pack.

Walking my dogs, off leash, as I too exercise, is one of the greatest joys I have living here. Its been awful since the Covid restrictions have been instituted. I think most other dog owners feel the same and that is why Page Mead, a person I deeply respect once observed that dog owners are "Kittery's NRA". If that means we are increasingly vocal, organized, and committed to the preservation of our privileges, then I think he was spot on.

Dog ownership is an increasing reality of modern family life. Fully 38% of Mainers owned a dog or multiple dogs before the Covid19 crisis and anecdotal data by Maine's animal shelters indicates that number has increased since the crisis began. Businesses that cater to pet owners is a large and growing part of our state and nation's GDP. And realtors know that designating a community as "pet friendly" drives sales. You heard that sentiment from new homeowners in the letters you have already received. Young families have sought to live in Kittery because of our pet friendly amenities. Fully 80% of American mayors surveyed indicate that local availability of pet friendly amenities increases the value of residential properties. Dogs and dog owners are here to stay. We are good neighbors, volunteers, and civic participants. Dog owners on average know more people in their towns than other residents because dog ownership builds social capital among citizens.

I have researched and gathered a lot of data about the benefit of dog ownership (including to the mental and physical well-being of their owners) and have started to review the developing body of case law that challenges municipal ordinances that unfairly penalize law-abiding dog owners. Our town should seek to remain on the right side of this issue and not cause more community distress than we are already experiencing during this pandemic. The balance between public health and safety and the privileged use of public spaces to adequately exercise our pets (and concurrently, ourselves) is our shared concern. If there are recorded incidents of dog attacks, fights, and injuries that warrant pulling back on citizens' privileges I'm sure the community would like to see that data and evaluate the reasonableness of making adjustments. As someone who is at one of Kittery's three public properties on a daily basis I can honestly say I have witnessed or experienced only one or two minor incidents in my thirty years of pet ownership. Are some people jerks who choose not to train or control their pets? Sure. No ordinance will change that. That said, the idea that there is a deep docket of complaints is, I think, over-dramatized. Of course, we can all commit to doing better and my recommendations on this are fairly simple:

First, continue to have hours restrictions in the summer months for off-leash dogs at our Town parks. Because Kittery citizens wish to preserve their privileges, it would be a rare occurrence indeed to find a resident violating these parameters.

Second, post clearly the restricted hours and monetary cost associated with violating our ordinance on signs. Get rid of signs that give conflicting information. Other towns do this successfully. Set the right expectation through clear information with visitors who are dog-adverse so they may knowingly choose different hours to visit our public properties in the summer. Since most of the hours are dedicated to the non-dog cohort, it should be a reasonable compromise.

Third, it is time for the Town to install and service waste receptacles. I pick up my animals' waste and bring it home in a bait bag. However, since there is an indication that waste is an issue, it is time to implement a system to collect it. As a community we can develop innovative ways to generate the revenue necessary to offset costs. To clarify a recent statement made at the August 10<sup>th</sup> Council meeting, poop in a bag is no more hazardous than other types of waste found in a trashcan. Other communities find a way to provide this service for community health and safety and I know Kittery can too. Having dedicated animal waste receptacles is but one of the criteria used to designate a community as dog-friendly. More information on this can be found on the Better Cities for Dogs website, a national effort to develop progressive pet policies and planning.

I am all for more strenuous enforcement of our animal control ordinances if they remain reasonable. The current ACO Officer Byrnes is not the town employee to do it. I have formally complained about my three interactions with him to the Town Manager and have been told my complaint was shared with the Chief. I have not had any response to my complaint. I am one of many citizens who has found Officer Byrnes caustic, aggressive, and rude. An ACO, who is a highly visible community liaison, should like both animals and people and treat both with respect. I ask that the Council consider whether any agreeable compromise will be successful if he continues serving as our ACO.

In conclusion, like many dog owners I am alarmed at what I have read in Title 6. I hope the Council will consider the importance of dogs in the lives of its residents and rely on the ample body of best practice in other communities to develop a workable solution with its resident dog owners. We should seek a simplified ordinance that is enforceable and that won't cause broad community resentment nor drive potential residents away. If a citizen working group is needed to explore reasonable and progressive options I would be happy to volunteer for such an effort.

Thank you for taking my thoughts under consideration. Please read my comments into the public record on August 24th, thank you.


#### A few particulars:

- 1. I have often noted that the current regulations around dogs are NOT followed by my fellow dog owners. I would therefore suggest that the Town do more to enforce the current laws instead of adopting new, more restrictive laws, as they pertain to dog owners.
- 2. Dogs need to run. I appreciate the quality of life in Kittery because I can take my dogs to the beach and some parks so they can run free. The Town has created and enforced a policy where dogs are prohibited from Fort Foster and Seapoint Beach from 10 AM to 5 PM. To be fair to dog owners, should we not allow time on the beach for dogs and their owners and ask those people who are afraid of dogs or do not like dogs to NOT go to the beach during those times? By fair I mean providing beach time for the many tax payers in Kittery who want to run their dogs on the beach or in select parks. Several other Towns provide time in the morning for dogs to run on the beach and in parks. For example, York allows dogs to run free on the beach all summer before 8 AM. Durham, NH also allows dogs to run free on Wagon Hill Farm before 10 AM. Signs clearly indicate the policy and it works very well.
- 3. Section 6.1.4.D in the amended Title 6 (Aug 17, 2020 Draft) states "No responsible party may have more than 1 dog under voice control at large on public property, at any time." This is idiotic. If I take two dogs to the beach to run, how can they run and play if one of the dogs is on a leash? Short answer is they can't. The issue of dog walkers taking hoards of dogs for walks in Kittery is clearly dealt with in Section 6.1.4.E. You should at the very least allow any responsible party to have 2 dogs under voice control.

In closing, there is broad research that shows dogs need a place to play and run, dogs promote activity in children and families, dogs strengthen human communities, and dogs help build social capital. Please keep Kittery dog friendly. Please do not adopt the overly restrictive amendments that require us to walk our dogs on leashes in Kittery's public spaces at all times.



Please refocus some of your attention <u>away from dogs for a moment</u> and address this very serious problem.


When citizens start using guns and poison against an out of control animal population, there is a problem that needs to be addressed.

The lack of enforcement of the rules allows for problems. It's equivalent to the idea that more people would be inclined to speed on the roads if they knew they wouldn't get a ticket.

The rules we have would work fine if there was better enforcement at the parks.

AND, it would help people dispose of the dog waste if receptacles were provided. Since providing dog waste bags has made a difference, that would be the next step. There are covered receptacles available with small enough openings that the argument that they would get used for all sorts of other trash does not apply, especially if they were clearly marked DOG WASTE ONLY and put in locations where they are needed. Surely the big revenue that these places provide to the Town of Kittery would outweigh the costs of the cans and the disposal of the contents!

#### Good morning—

I'm a resident of Kittery Point and wanted to comment on the question of dog restrictions at Fort Foster, etc.

I don't personally have a problem with dogs being present at certain areas of Fort Foster or at Seapoint. But enforcement of the leash requirement at Foster really has to happen (I'm not aware if a similar requirement applies to Seapoint). At Fort Foster, people let their dogs off leash from time to time. Chances are slim that a dog will bite a person, but it will happen. More frequently, dogs will run up to people and jump on them, and this is generally unwanted. That's the reason for the leash requirements.

Far more problematic are the issues of dog waste and barking. There has to be better enforcement of dog waste removal requirements at Seapoint and at Fort Foster. There's no excuse for leaving bags of dog waste lying on our beaches. It's unacceptable. I'm in favor of sharing designated areas with leashed dogs, but if abandoned bags of dog waste continues to be a problem, I will no longer support sharing these spaces with dogs. I love dogs, but removing their waste is respectful of others who share these parks.

The issue of barking is as much a problem as the waste, but in neighborhoods, specifically ours near the Kittery Point Citgo. There are existing statutes against nuisance dog barking, but they are completely unenforced. Area dogs are sometimes allowed to bark for 30 or 40 minutes. It ruins the peace, which is the whole reason for the statute in the first place.

Good relations between dogs, dog owners, and others rely on clear rules, that the rules are followed, and when they are not, that there is enforcement that carries with it meaningful consequences (like fines) to curb the behavior. Otherwise, it's not going to work and these kinds of proposals to restrict dogs are going to carry the day.

I want to share my concern that it appears the council is looking to restrict access to dogs at Fort Foster and I am not sure if there are proposed changes to Seapoint Beach. I too am concerned when people do not pick after their dogs or keep them under control. My concern is that there has been little dialogue with the residents of Kittery to collaborate on how to solve these issues. I have been a responsible dog owner and resident for 40+ years. I have always picked up after my dogs and they have been under my control. For me this means, when I am near people my dog is on a leash. However, when I am not near others (often alone on the walk or at the beach area) I want him to enjoy running around off leash or taking a swim (not near others). He is never far from me or out of my control. This occurs most often in the non-summer months. During Covid I understand the need for the leash at all times.

I feel I have a right to access the town beaches with my well behaved dog as a tax paying responsible citizen. I can support penalizing (e.g. tickets, losing their pass, etc.) those who are not responsible. I have picked up others bags. I would be willing to speak with others to remind them of the rules for park employees cannot, nor should have to, do it alone. Thank you for your time and consideration.

I am a resident of Kittery Point and I an almost daily user of both Fort Foster and Seapoint. I wanted to submit comments regarding the presence of dogs and their owners in our public parks and spaces, but also in the neighborhood where I live.

Throughout my life I've had dogs, though not at present due to a recent death, and so I am not unsympathetic to their kind, but I am quite concerned about the amount of dog waste in our parks (even if bagged and waiting on a stone for someone to claim it later). This is unsightly, often smelly in summer, and simply not acceptable. Said another way: it's disgusting. I've never seen as much in any other town as I've seen since moving here.

Of even more concern is the barking. During a recent and very busy Saturday in late July, I took my family to Fort Foster and found there, among the many sunbathers and swimmers, an off-leash dog barking and running rampant along the Divers Beach. The owner and her two adult companions seemed entirely at ease with this situation. I took my kid and moved to another location so that we could have some peace.

I don't mind sharing these beautiful places with responsible dog owners but it's not enjoyable when they flaunt the rules. There needs to be some kind of enforcement when folks don't obey the very clear signs that are posted.

Even more of a problem is the barking I hear every day where I live, on Haley Road, near the Citgo Station, I have read the local ordinances so I know it's okay but where is the enforcement? I have lived here a year and a half and a new resident, decided to see if it would change before calling the police. I don't know many of my neighbors and don't want our first contact to involve a complaint, so it would be nice if local authorities could handle this sort of thing as a way of preserving neighborhood harmony and quality of life.

First, I would like it be known that I love dogs. If I didn't travel so much, I would have a dog. I think it's critical for them to have a place to run and play off leash.

However, I don't think Fort Foster is an appropriate place for that. I rarely visit Fort Foster, even though I live just up the street, because of the sheer number of dogs that are there before the park opens. When I first moved here, I noticed a large sign proclaiming that the park would be closed to dogs if poop wasn't picked up. It's been an empty threat all these years since I have noticed many dog poop bags left behind, tossed into the woods, and dog poop on trails. In addition, it is common to see dog poop bags on Pocahontas Road that have fallen off the rear windshield wipers of cars.

Dogs in Fort Foster are rarely kept on leashes and it is not unusual to have one come bounding over and leap on you. Owners are quick to say that their dog is friendly. But if one is dog-phobic, that is of little comfort. A dog-loving friend of mine was walking recently (in another state) and reached down to pet a dog (with permission from the owner, who is a veterinarian). The dog mauled her and she required 40 stitches in her face. This is an extreme example, but these types of negative interactions are possible when dealing with animals. There are town residents who would love to walk in the park but don't because of the number of dogs there every morning.

When owners walk their dogs off leash, they often are not in sight of their dogs. The owners are sometimes engaged in conversations with other people or walking ahead of their dog and don't notice that their dog has pooped, therefore the poop doesn't get picked up. It's even worse in winter when snow piles are covered in dog poop. Owners in the winter often don't bag up the poop and it is left to sit on the snow until spring. It's rather disgusting.



- 6) Socialization can only happen if said child or dog is not being held back by an adult hand or leash.
- 7) Socialization for children and dogs have a time, place and space for interaction and involves positive progression.
- 8) Lack of a chance for socialization & freedom [while being supervised] is dangerous for society as a whole. Dogs and humans, even adults need socialization.

Fort Foster & Sea Point Beach are owned by the citizens of Kittery and Kittery Point.

They are 2 wonderful places for families with children, families with dogs, people who want to be outside socializing or exercising and people who periodically want to escape their isolation or find a space to observe the greatness of the ocean and find an inner perspective to interact.

Respectfulness towards others is being neighborly.

For the sake of those who don't want to see a dog, there are wonderful "nooks" at Fort Foster.

No dog anywhere should be out of control of the responsible owner. No child should be left unsupervised on the trails, rocks, or beaches of Fort Foster.

My own dog is afraid of children because of their unpredictability....even with wonderful care givers. So my dog often won't even get out of the car during summer at Fort Foster.

But I still buy my seasonal pass and I don't resent children using the park.

Dogs being leashed while they enjoy the park with their families makes sense.

In the same way there is a beach at Fort Foster reserved for children, maybe there could be a beach reserved for dogs. Or perhaps only at low tide can dogs run on the beach. But they need some designated time or place to be able to interact without a leash. Otherwise, we will have a society of mean/fearful or overly protective dysfunctional dogs.

The trails are too narrow for dogs to enjoy interacting off leash. So mandatory leashing benefits all.

Sea Point could have off leash hours - maybe low tide.

Dog poop pick up has been discussed and vastly improved. If a dog owner is distracted by something - others point out to the owner "your dog just pooped"..."pick it up."

Kittery Land Trust does a great job of picking up Sea Point Beach. Washed up lobster or fishing gear is a far more common sight than a bag of dog poop.

Banning dogs all together from either place only creates an unneighborly, mean spirited community of judgemental resentful people.

It is a proven scientific fact that if isolation or addiction is a problem in your life, then caring for an animal in a wholesome way is part of a solution.

My wife and I have lived on Pocahontas Road since 2013. Due to our personal experiences living on the road into Fort Foster and inside the park itself for the past seven years, we are strongly in favor of a dog ban at the Fort. There are simply too many irresponsible dog owners who have, in spite of numerous warnings from the town, continually spoiled the situation for responsible dog owners.

Every day we are confronted with drivers racing down Pocahontas at over 50 mph, their dogs baying out their car windows and bags of dog waste attached to their back wiper blade. We are dog owners, and our dog walks only on leash. We have tried walking our dog early in the morning in the Fort (before the current COVID restrictions), and have found it to be impossible - our leashed pup was aggressively approached by unleashed dogs whose owners were many yards away. Even without our dog in tow, we have tried walking in the park at various hours of the day and have often been accosted by unleashed / unattended dogs. In our opinion, dog owners using the park have not been responsible - it is a situation that is out of control and needs to be addressed.

Since there is currently no prohibition on dogs, Fort Foster has essentially been operating as a de facto dog park, with daily visitors from multiple states and local municipalities. If this is what Kittery chooses for a uniquely picturesque and pristine asset then so be it, but we believe that it is simply unfair to the numerous other people who expect to spend time in a beautiful town park without having to worry. We have been sorely disappointed in our town's failure to address these issues - from owners not cleaning up their dogs' messes to problems with aggressive, unruly dogs that are off leash in defiance of the park's rules. We sincerely hope that our community will honor and respect our rights to enjoy this precious landscape safely and without fear of being accosted by pets whose owners fail in their responsibilities to both the pets and their community.



I understand the town of Kittery is thinking about making Seapoint and Fort Foster Leash only, all the time.

I find that frustrating and unfair. There have been 3 main complaints I hear:

- that some people don't pick up after their pets. true. Some people suck. But it seems to me there are far more people who leave diapers, condoms, coffee cups, beverage containers, half eaten meals in plastic, and cigarette butts. Those last items mentioned are all items that have been in someone's mouth/body - leading to a greater threat of COVID spread, which seems to me is a bigger threat.
- I have heard there is a concern about the spread of COVID via petting a dog, but, according to the CDC:
  - At this time, there is no evidence that animals play a significant role in spreading the virus that causes COVID-19.
  - Based on the limited information available to date, the risk of animals spreading COVID-19 to people is considered to be low.

- There are also comments about misbehaving dogs. Through my decades of being in public with and around dogs, I have witnessed very few incidents and have found that the dog community is good about self policing those that are ill behaved.

There are fewer and fewer places available for our dogs to really get to RUN. I have a small yard, but to really expend the energy he needs to, my rescue pup needs a good full out sprint. Having other pups to chase and run from are an important part of his socialization, and mental & physical health.

Part of the reason we bought a house in Kittery is because our families' home is about 5 minutes from both Seapoint Beach and Fort Foster. We plan on staying here for a lifetime and raising our kids here but if this is the kind of leadership our town has, we have no problem leaving. Our house, like many in Kittery, is only on a small parcel of land, where we cannot give our dog long ball throws. We visit Fort Foster and Seapoint almost every day to unwind before and after work.

The revenue loss alone from Fort Foster of dog owner visitors to our town should be enough to dissuade the Town Council from moving forward with something like this. I can guarantee that the revenue of visitors that come to the park with dogs easily covers that \$2,000 our town spends on poop bags.

There are **many** good alternatives to banning dogs, such as, leaving the rules the way they were. Another suggestion other than banning dogs outright would be to have limited off-leash hours, much like Wagon Hill in Durham, NH. At Wagon Hill, dogs are allowed off-leash under voice control before 10:00am; between 10:00am-5:00pm dogs must be leashed. It works really well there. That would be a really simple, enforceable solution that would work at both Fort Foster and Seapoint Beach. Also, they have several

trash cans throughout the beautiful park and lots of people use them. Empty them once a day and your "problem" is solved.

Please listen to the people, you are not representing our town well in this matter.

I understand the town of Kittery is thinking about making Seapoint and Fort Foster Leash only, all the time.

There have been 2 main complaints I hear:

- that some people don't pick up after their pets. true. Some people suck. But it seems to me there are far more people who leave diapers, condoms, coffee cups, beverage containers, half eaten meals in plastic, and cigarette butts. Those last items mentioned are all items that have been in someone's mouth/body - leading to a greater threat of COVID spread, which seems to me is a bigger threat. People not cleaning up after themselves is sometimes a problem but it is not a dog problem.
- I have heard there is a concern about the spread of COVID via petting a dog, but, according to the CDC:
  - At this time, there is no evidence that animals play a significant role in spreading the virus that causes COVID-19.
  - Based on the limited information available to date, the risk of animals spreading COVID-19 to people is considered to be low.

There are fewer and fewer places available for our dogs to really get to RUN. I have a small yard, but to really expend the energy he needs to, my rescue pup needs a good full out sprint. Having other pups to chase and run from are an important part of his socialization, and mental & physical health.

Most people always pick up after their dogs, and sometimes other's pups, for those who may have missed it. It happens. There are loads of other places to go for those who don't like dogs, but precious few where people can be outside with their well behaved dog off leash. We have been sharing these spaces for years with little issue. I don't understand the sudden need to disrupt what has been a mutually beneficial arrangement at Sp and FF. There are dog allowed hours and there are people only hours. People know what these are and can choose accordingly if they wish. Choosing to go to the beach at various times to meet our own wants and needs is normal. I don't go on weekends because I know it will be busy. I go more off season for the same reason. If I did not like dogs, I could go to another beach or choose a time when I know that dogs will be on leashes.

The current rules regarding dogs at Kittery beaches are fair and equitable and do not need changing. What we have in place is working! Thank you for your consideration.



Hello,

My wife and I recently bought a home in Kittery, and are looking to start a family here. The town atmosphere and facility access (including Seapoint Beach, Ft Foster) were two of the many reasons we chose to settle in Kittery after we returned to New England following my military service.

We are dog owners and truly enjoy being able to take our dog on walks around the town, especially Seapoint beach and Ft Foster during the prescribed dog use hours. We would be very disappointed were the Town Council move to amend Title 6 to ban dogs on Seapoint Beach and Ft Foster.

We understand people do not like dog waste left in public spaces, and as responsible dog owners we wholeheartedly agree that people need to clean up after their animals. We are truly outraged when we see dog waste in public spaces because people are too lazy to clean up after their animals. We believe irresponsible owners should be held to account (fines, what have you) vice punishing responsible owners by restricting appropriate use of public spaces.

We do not believe a dog ban will wholly solve the problem of dog waste on the beaches. The same people who don't clean up after their dogs will likely ignore the ban. What about human generated waste (trash, firepit residue, etc)? A ban on litter doesn't stop people from littering. Public waste bins and fine enforcement should be used to help mitigate the impact of negligent use. we urge the Town Council to consider these actions in lieu of an outright ban.

Lastly, we imagine Ft Foster revenue/usage may decrease due to dog owners not being able to visit the beach with their dogs. How much of the nearly \$200,000 in Ft Foster fee revenue comes from dog owners? Or day pass users with their dogs? We would certainly reconsider buying a Ft Foster pass if we could not bring our dog.

Please do not ban dogs on Seapoint Beach and Ft Foster. Instead, please consider alternatives: fine enforcement, waste bins, etc to mitigate the animal waste in public spaces.

Dear Members of the Kittery Town Council,

Thanks you for your service to our town.

Establishment of a new municipal ordinance should be driven by data that presents clear evidence of need for that ordinance. It should also point to outcomes that would indicate whether or not a policy met its goals.

I have to say I have not seen the Town Council or others present a concrete set of data indicating a problem with dogs at Seapoint or Fort Foster to warrant the town government to reach in and further regulate these spaces for dog owners. Yes, I have heard the anecdotal tales from Councilors and a few others about bad behavior of dogs on the beaches. My anecdote is that I've taken my dog to Seapoint in the early AM most weekend mornings for the past ten years and I've never had an issue with another dog and would add that there's a lovely community of folks who gather in these early hours to walk and talk while their dogs romp. I bring this up not to be convincing, but just to show my anecdote is equal to those who would use their stories as leverage to capriciously choose to restrict these sites. They're both tiny samples, and they're both useless.

As a taxpayer, I would like my governing body to present evidence of need before treading into regulation. I can't remember to whom to attribute the quote "Without data, you're just another person with an opinion." Thus far I've only seen a lot of opinions and personal anecdotes and I don't believe municipal ordinances should be driven by the dispositions of its leaders.

Yes, sometimes I see dog poop or a bag of it an irresponsible dog owner didn't pick up. I see lots of things on the ground in Kittery proper that I don't want to see. There are fresh empty Fireball nips in the ditch on my street every morning.

Our town has significant matters worthy of the attention of Town Council and town resources. Those resources are stretched and I can't imagine allocating them towards enforcement of something so trivial as dogs on beaches. Again, if there were data presented to support the evidence of a significant issue, I would drop the 'trivial.' Absent data, I have to go with my own observations which don't demonstrate a need for further government regulation beyond the restrictions that already exist.

Counselor Thompson said he would get in trouble for his remarks about how only people with yards should have dogs, and the elitism of his remark is troubling on a number of levels. I'm sure he'll take a substantial amount of heat as he predicted. For me the most disturbing aspect of it is it runs against the grain of what I hope remains culturally a salt of the earth kind of town. I know

living here 20-plus years makes me a relative newcomer, but I value the simplicity, community, and the freedom we have in our beautiful spaces. I worry about the incursion of literal and figurative gates, signs, and barriers to the areas that make this a unique place to live.

There's no need to step into this. Thank you for your consideration.
