

GENERAL BID FORM

- A. The undersigned proposes to furnish all labor and materials (except materials provided by TOWN) required for the Water Main Extension Project construction in accordance with the accompanying PLAN and specifications for the contract prices specified below, subject to additions and deductions according to the terms of the specifications.
- B. The undersigned certifies that he/she has carefully examined the form for bid, the general conditions, the specifications, the special conditions, and also the site of work and will provide all necessary machinery, tools, apparatus, and other means of construction, and do all the work and furnish all the material called for in these specifications, general conditions, special conditions in the manner prescribed therein and in accordance with the requirements of the Town of Kittery under them.
- C. This bid includes addenda numbered through: _____
- D. **The TOWN will supply the CONTRACTOR with 6", 8" and 12" ductile iron water main pipe, plastic meter pits and concrete meter pits at no cost to the CONTRACTOR.** All other required materials (including hdpe and plastic pipe), fittings, valves, hydrants, restraints, services and appurtenances to be provided by the CONTRACTOR and their associated costs included in the unit bids.
- E. The base contract includes, but is not limited to mobilization/demobilization, traffic control, general earthworks, layout, finish grading, and restoration to pre-excavation conditions. The base contract shall be paid on a line-item basis at quantities accepted by the TOWN in accordance with the General Requirements attached hereto. The proposed base contract price is:

F. The undersigned agrees that, if selected as CONTRACTOR, they will within ten (10) days, Saturdays, Sundays and legal holidays excluded, after presentation thereof by the TOWN, execute a contract in accordance with the terms of this bid and furnish a payment bond, of a surety company qualified to do business under the laws of the State and satisfactory to the

TOWN in the sum of one hundred percent (100%) of the base contract price and selected bid alternatives, and a performance bond, of a surety company qualified to do business under the laws of the state and satisfactory to the TOWN in the sum of one hundred percent (100%) of the base contract price and selected bid alternatives, the premiums for which are to be paid by CONTRACTOR and are included in the contract price; provided, however, that if there is more than one (1) surety company, the surety companies shall be jointly and severally liable.

- G. The undersigned hereby certifies that he is able to furnish labor that can work in harmony with all other elements of labor employed or to be employed on the work; that all employees to be employed at the worksite will have successfully completed a course in construction safety and health approved by the United States Occupational Safety and Health Administration that is at least 10 hours in duration at the time the employee begins work and who shall furnish documentation of successful completion of said course; and that he will comply fully with all laws and regulations.

- H. The undersigned further certifies under the penalties of perjury that this bid is in all respects bona fide, fair and made without collusion or fraud with any other person. As used in this subsection the word "person" shall mean any natural person, joint venture, partnership, corporation or other business or legal entity.
