## ITEM 1 – Land Use and Development Code (Title 16) Amendments – TITLE 16.8, ARTICLE X. Signs

The proposed amendments clarify and update the sign regulations relative to message boards / internal & external lights and timers; number and sizes of free-standing signs allowed; temporary signs; sign location; character/appearance and sign permit application/administration procedures.

<u>Public Hearing, Vote to Recommend.</u> Take public comment. Review and discuss proposed changes to ARTICLE X Signs. Vote to recommend to the Town Council.

### **OLD BUSINESS**

#### ITEM 2 – Town Zoning Map Amendment: Neighborhood Mixed – Use (MU-N) Zone

This zoning map amendment is the second step to a two-part process replacing the Business Park (B-PK) zoning district. The first step proposed a text amendment changing the B-PK zone to the Neighborhood Mixed-Use (MU-N) zone and replacing the zoning requirements. That step is under consideration via Public Hearing before Town Council on September 24, 2018. The Planning Board previously held a Public Hearing for the proposed text amendment changes on June 14, 2018. This second step proposes a zoning map amendment to expand the proposed boundary of the Neighborhood Mixed-Use (MU-N) zone, if the proposed text amendment is adopted by Town Council. The Planning Board held a Public Hearing on the boundary change on August 21 and August 23, 2018 but did not take action at that time.

<u>Action:</u> Review and discuss proposed boundary changes to the former Business Park Zone, now proposed as the Neighborhood Mixed – Use Zone. Vote whether to recommend to Town Council.
