Policy & Program Update

- No Policy changes proposed.
- Added a "Projects on the Horizon" to inform longterm capital planning and unassigned fund (undesignated reserve) management.
- Developing detailed asset management plans for:
 - KCC Equipment
 - Police Equipment
 - Municipal Technology
 - School Assets

Overview

- RESERVE approach proving to be successful:
 - FY19 FY20 Purchase of Pumper \$550,000 on schedule, no debt.
 - FY20 had no significant impact on asset management plans despite prioritizing larger projects.


- FY21 consistent with prior year's projections.

 - Emery Field Phase 2





Combined CIP



Holding Accts

- Right of Way \$450,000.
 Includes paving, and some sidewalk and drainage work.
- Funding level supports ongoing implementation of Pavement Management Plan.
- Fire Apparatus rebuilding reserve for next replacement scheduled for FY26 ~ \$774,000

Reserve Accounts

- Propose funding Police Equipment Reserve firearms, firearms storage, crime scene equipment, etc.
- KCC gym equipment is difficult to find replacement parts due to age, kitchen equipment nearing end of useful life.





Projects & Debt

Projects

- Emery Field Phase 2 \$300,000
 - Total project cost \$706,372 (excluding design)
 - LWCF Grant Award \$300,000
 - Grant Match Warrant Article \$100,000



New Debt

- Library Expansion and Renovation ~\$350,000/annual
 - 20 Year Bond
 - Est. 3% rate (conservative)
