Barbara Jenny wrote in objecting to the way retail Marijuana lottery was conducted.

Shaye Robbins, 24 Heron Point Lane, Kittery Point, ME asked the Town Council to vote NOT to allow recreational marijuana until and at which time the US Federal law changes regarding the classification and legality. Ms. Robbins also expressed concerns regarding Councilor Clark participating in conversations, planning, and advocating for or against the recreational marijuana policy and planning in the community. Councilor Clark is also in the business of marijuana sales and cultivation.

Shaye Robbins, 24 Heron Point Lane, Kittery Point, ME suggested when the Town Council meets with the Taylor disposition team on 1/24/22, she would like them to ask that retaining the property, removing the building and moving the parking from the lot adjacent to Lil's, in equal measure of spaces, to the area of the property which is currently the Taylor building. The area adjacent to Lil's then becomes an urban park. Putting the Square back in Wallingford Square.

c. Chairperson's response to public comments.

Chair Spiller responded to Barbara Jenny and stated the Town Council approved, what they believed was a fair process concerning the retail marijuana lottery.

Chair Spiller responded to Shaye Robbins and stated Councilor Clark has abstained and removed himself during Council meetings so there would be no conflict of interest.

Chair Spiller responded to Shaye Robbins second letter and stated it would not have been appropriate to consider it during the executive session. Chair Spiller commented that during the 1/25/2021 Council meeting, the Council received a recommendation from the Taylor building committee that the Town should move ahead with the sale or long-term leasing to a nonprofit and the Council agreed to that.
