Whipple Road Design Question — Councilor Spiller asked about bike friendly mountable curbing. The design team was asked to incorporate it into the project. MDOT would not approve due to safety issues and design standards. That was checked by a traffic engineer, it is not a safety design when you don't have a cycle lane and cycle track. At this time, they could not get in Whipple Rd sidewalk project.

Update on Dineen – Mr. Dineen remains incarcerated and will appear for another testimonial next Friday. There is evidence to suggest whether he can come to compliance with the court order.

Comcast Live Transmission Sites – The status of what has been completed by Comcast was explained. The next step is to install and activate converter boxes at four of the five sites. There is a very complex process involved with developing a live transmission.
