1. Call to Order

Chairperson Beers called the meeting to order at 7:00 p.m.

2. Introductory

Chairperson Beers read the introductory.

3. Pledge of Allegiance

Chairperson Beers led those present in the Pledge of Allegiance.

4. Roll Call

Answering the roll call were Chairperson Gary Beers, Vice Chairperson Charles Denault, Councilors Frank Dennett, Jeffrey Pelletier, Jeffrey Thomson, Judith Spiller, and Kenneth Lemont.

5. Agenda Amendment and Adoption

Item 13g. was withdrawn from the agenda per the applicant's request. Original Item 13k. was revised to replace "their" with "Fort Foster". Original Item 13n. was moved and re-lettered as Item 13a. Councilor Spiller requested to add an item under New Business to read "The Kittery Town Council moves to rescind its March 27, 2017, censure of a municipal official member of the Planning Board because of the Town's failure to maintain confidentiality as promised and required under 1 M.R.S. §405 (6) (F) and 1 M.R.S. §402 (3)(C-1)(1)(D)."

The agenda was adopted, as amended.

6. Town Manager's Report

Town Manager Amaral reviewed her written report.

**Library Public Workshop** – The first public workshop will be held on Saturday, April  $22^{nd}$  at 10:00am at the Traip Academy Gymnasium. A brief presentation and overview of three options will be provided for the public to provide feedback and suggest a preferred option.

**Rokunohe Visit** – The Council is invited to join the annual Rokunohe visit welcome dinner on April 27<sup>th</sup> at 6:00pm. Council is also invited to attend the assembly on April 26<sup>th</sup> at 7:30AM at Traip Academy.

**2017** Construction Season – Town Manager Amaral provided details regarding the major construction projects occurring in the upcoming year.

**Crosswalk at Walker Street on Main** – Staff reviewed the request for a crosswalk on Walker Street at Main Street and it is recommended to refer to the current Kittery Foreside Land Use, Parking and Traffic Circulation Study to determine the safest and most advantageous option for pedestrians.

Parking Violation in Foreside – The Police Department identified the vehicle that was a

frequent violator of parking regulations in the Foreside along Walker Street and is following up with enforcement.

**Public Road at Rogers Road and Whipple Road** – Information regarding the commonly used pass through in this area was provided and additional research is forthcoming.

**Parking at Fort Foster Gate House** – The Police Department will make periodic checks to ensure that no vehicles are blocking Pocahontas Road.

Town Manager Amaral replied to Councilor Lemont that the request for a sidewalk on Route 103 extending from Austin Hill to Kittery Point Bridge is currently in design and Right-of-Way work and scheduled to be constructed in 2018.

Town Manager Amaral provided specific details regarding legal considerations and timeline in order to demolish the building on the Dineen property.

Town Manager Amaral noted that MDOT intends to complete drainage work on Route 1 while the Sara M. Long bridge is under construction.

7. Acceptance of Previous Minutes

The minutes of March 27, 2017 regular meeting were adopted, as amended, with Councilor Thomson abstaining.

# 11. DISCUSSION

a. Discussion by members of the public (three minutes per person)

#### Vern Gardner, 2 Tuckers Cove

Mr. Gardner spoke about a citizen's right to speak freely without fear of being evicted or bullied. He disclosed that he filed a personal lawsuit against Gary Beers and noted it is not against the Council.

#### Susan Johnson

Ms. Johnson spoke in favor of allowing low income, elderly residents to attend adult education classes at no charge. In response to the Foreside study, she advocated for new design ideas that preserve trees, provide green space, and to bury utility poles underground.

# Susan Emery, 5 School Lane

Ms. Emery provided history and information regarding the ballot initiative seeking a York County casino or slot machine facility. She spoke in opposition of the initiative highlighting the negative impacts a casino would impose on Kittery and York County.

# George Dow, 1 Bartlett Road

Mr. Dow thanked Superintendent Allyn Hutton for her dedicated service. He described and

complimented the recent Heart to Art event. At the event, third graders of the Horace Mitchell Primary School and the Maine Chapter of the Alzheimer's Association taught art lessons to seniors with early on-set dementia.

- c. Chairperson's response to public comments

He provided no comment to Mr. Gardner since he had departed the room. In response to Ms. Johnson, he referred to Town Manager Amaral regarding adult education classes for the elderly and any plans for cutting trees in the Foreside. In response to Ms. Emery, he welcomed her sentiments regarding the York County ballot initiative. In response to Mr. Dow, he echoed his sentiments regarding the accomplishments of the School Department under Superintendent Hutton's leadership.

- 13. NEW BUSINESS

a. (040117-14) The Kittery Town Council moves to reaffirm the Town of Kittery's opposition to a casino in Kittery, as stated in Sec. 1.04 of the Kittery Town Charter and asks the Town Manager to work with comparable officials in surrounding communities to develop a strategy in opposition to the November statewide ballot referendum question on locating a casino in York County.

# A MOTION WAS MADE BY COUNCILOR SPILLER TO REAFFIRM THE TOWN OF KITTERY'S OPPOSITION TO A CASINO IN KITTERY, AS STATED IN SEC. 1.04 OF THE KITTERY TOWN CHARTER AND ASKS THE TOWN MANAGER TO WORK WITH COMPARABLE OFFICIALS IN SURROUNDING COMMUNITIES TO DEVELOP A STRATEGY IN OPPOSITION TO THE NOVEMBER STATEWIDE BALLOT REFERENDUM QUESTION ON LOCATING A CASINO IN YORK COUNTY, SECONDED BY COUNCILOR THOMSON.

The Council discussed the purpose of reaffirming Section 1.04 of the Charter. Councilor Spiller explained that it reinforces her view of opposing any casino along I-95 and spoke about the negative impacts that are associated with this type of proposal. Councilor Dennett asked to divide the referendum question. Councilor Lemont stated in support of the motion and expressed concerns for potential impacts to surrounding communities.

# THE MOTION TO REAFFIRM THE TOWN OF KITTERY'S OPPOSITION TO A CASINO IN KITTERY, AS STATED IN SEC. 1.04 OF THE KITTERY TOWN CHARTER PASSED BY A UNANIMOUS ROLL CALL VOTE 7/0/0.

Councilor Spiller clarified that surrounding communities consists of at least, but not limited to, any Town adjacent to Kittery. Councilor Dennett spoke in opposition of the motion because he could not speak for other communities in York County and he did not support requesting the Town Manager work on a task that is not directly related to the Town. Councilor Pelletier felt that the motion allows for the Town Manager to work with other York County communities. Vice Chairperson Denault echoed Councilor Dennett's statement.

# THE MOTION PASSED BY A ROLL CALL VOTE 5/2/0 WITH VICE CHAIRPERSON DENAULT AND COUNCILOR DENNETT OPPOSED.

He announced the Kittery Community Center's 5-year anniversary celebration will be held on Saturday, May 20<sup>th</sup> from 10:00am-1:00pm. He noted an additional part-time preschool program at KCC will be added in the future.

Vice Chairperson Denault referred to Town Manager a complaint he received regarding runoff directed onto residents' properties on Woodlawn Avenue.

Councilor Spiller reported that the recent dog waste cleanup effort resulted in a minimal amount of dog waste collected. She noted that the Comprehensive Plan Update Committee will be looking into ways to encourage the use of solar power on private properties.
